



BACKGROUND: In April 2011, DHCD's Neighborhood BusinessWorks lent Limerick Pub, LLC \$335,000. The borrower used the loan to finance the furnishings, fixtures and equipment for a start-up Irish-themed bar at 11301 Elkin Street, Wheaton. To secure this loan, DHCD took an interest in the furnishings, fixtures and equipment and an Indemnity Deed of Trust on two of the three principals' residences:

- 3101 Moore Lane, Kensington
- 2711 McComas Avenue, Kensington

Reference is made to Secretary's Agenda Item 11 (April 17, 2013) in which the Board of Public Works approved DHCD's recommendation to substitute for loan collateral an indemnity deed of trust on 6101 Granby Road, Rockville (a property owned by the third Limerick principal) for 3101 Moore Lane. The Board's approval of that recommendation meant the DHCD loan is now secured by the furnishings, fixtures and equipment and an Indemnity Deed of Trust on:



PROPOSAL: Cornelius B. Foley who owns 2711 McComas Avenue, Kensington, no longer wants to be involved in the business and wishes to sell his interest to co-owner Thomas Stanton. The buyout agreement requires Stanton to substitute his personal residence, 3101 Moores Lane, Kensington, as collateral. Approval of this request will facilitate a transfer of ownership interest for a loan that has performed since inception. The Board's approval of this current recommendation will mean the DHCD loan will be secured by the furnishings, fixtures and equipment and an Indemnity Deed of Trust on:

- 3101 Moores Lane, Kensington
- 6101 Granby Road, Rockville

The substitution will decrease the collateral market value from \$418,575 to \$417,575 which is within the Neighborhood Business Works Program limits of 80% loan-to-value for real property and 50% loan-to-value for furnishing, fixtures and equipment

RECOMMENDATION: That the Board of Public Works approve the leasing of 5.75 acres of a 23 acre parcel that secures DHCD's financing for the first phase of the Lodges at Naylor Mill Senior Housing (Lodges 1). The lease will permit the development of a second phase of the Lodges at Naylor Mill Senior Housing (Lodges 2). DHCD counsel advises that Board of Public Works approval is necessary as DHCD is recommending an action that affects the State's security on this project. The creation of a ground lease on property that secures a DHCD-financed project constitutes such an action.

HISTORY: In May 2006, DHCD provided Low Income Housing Tax Credits and HOME funds to The Lodges at Naylor Mill LP to construct 65 units of affordable senior rental housing on 23 acres of land in Salisbury, Wicomico County. The project, Lodges 1, was completed in August 2007; it has been fully occupied since it opened and currently has a waiting list of 74 households.

Lodges 2 is now being proposed. While the development team for the second phase remains largely unchanged, the Volunteers of America, Inc., a large national affordable-housing developer, is being added to the ownership entity and will serve as governing General Partner.

5. **DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT** (cont'd)

To avoid an expensive and time consuming subdivision process due to VOA's entry into the project, the developer is proposing a ground lease approach to develop Lodges 2. The developer plans to submit the project for DHCD funding, which funding requires an applicant to evidence site control. The ground lease that the developer seeks permission for is sufficient to give the developer viable site control.

VALUE: The value of the 5.75 acres to be covered by the lease is being determined. Given the property will remain in the hands of the owner and continue to be part of DHCD's security for the Lodges 1 loan, the impact of the ground lease upon the State's interest in the existing property is minimal. If a significant payment to the owner is required by the lease agreement, DHCD will share in those proceeds.

Nature of Emergency: The State Board of Nursing is subject to periodic evaluation under the Maryland Program Evaluation Act, a sunset review process that evaluates entities subject to termination. The Department of Legislative Services completed a full sunset evaluation in 2011 and recommended extending the Board of Nursing through 2023. DLS also indicated that the Board of Nursing could improve service to licensees, certificate holders, and the public. An evaluation of the Board must be performed by December 31, 2013 with a report to the General Assembly. Nature of Emergency: DHR's WebEx service includes online training, meetings, and conference calling. Furthermore, as part of Maryland's Healthcare Insurance Exchange project, DHR began training users Statewide via WebEx in July 2013. Not having WebEx would jeopardize HIX training.

DHR made two unsuccessful attempts to procure a continuation of WebEx services, one attempt through DoIT's COTS master contract and the other attempt through the federal GSA schedule. Over the past three years, DHR has renewed WebEx services through the COTS master contract. During FY13, DHR sought to renew WebEx through COTS, but DoIT now considered WebEx a service (not software) and COTS is appropriate only for software. DHR then worked with DoIT to renew WebEx services via the federal GSA schedule. However, the sole GSA-approved vendor was not in good standing with the State Department of Assessments and Taxation. Because of the delays from the unsuccessful procurements, this emergency procurement became necessary to prevent interruption to DHR's WebEx service.





REQUESTING AGENCY REMARKS: A notice of availability of the Request for Proposals (RFP) was advertised on *eMaryland Marketplace* and the DHMH web site. Additionally, a copy of the solicitation was emailed directly to seven potential offerors, all of which are Maryland firms and MBEs. A copy was also sent to the Governor's Office of Minority Affairs.

Ten proposals were received in response to the RFP from five offerors. One offeror submitted offers for all five categories (each region and Statewide). All five offers were deemed not to be reasonably susceptible of being selected for award and were rejected. The remaining five proposals were deemed to be reasonably susceptible of being selected for award and were evaluated by region. Humanim, Inc. submitted proposals for the Central region and Statewide. The other offerors submitted single proposals for the regions that they currently serve. Only one proposal was submitted for each region; therefore, each region stood on its own merit.

The basis for contract award was established in the RFP to consider awarding a single Statewide contract or individual regional contracts. The four highest ranked (blended technical and financial) regional proposals would be considered collectively and compared with the highest ranked (blended technical and financial) Statewide proposal. The highest ranked proposal between the two proposals compared (collective and Statewide) would be determined to be the most advantageous to the State considering technical evaluation and price factors as set forth in the RFP. If the award would not made to the offeror submitting the Statewide proposals (highest ranked) in each of the four BSS regions. In making this determination, technical factors received equal weight with price factors.

The Statewide technical proposal from Humanim, Inc. was compared collectively against the four individual regional proposals. It was determined that Humanim's statewide technical proposal was ranked higher than the four regional proposals combined. Therefore, award is recommended to Humanim, Inc. for a Statewide BSS contract.

The benefits of the Statewide BSS contract include:

- 1. Providing consistent services across the State;
- 2. Offering a single point of contact for any issues with the services;
- 3. Implementing Statewide Best Practices more quickly;
- 4. Providing more accurate and complete data analysis by reporting it as a Statewide entity; and,
- 5. Tracking and trending data by region, as well as Statewide, consistently.

Two at-risk teens were placed with St. Ann's Center for Children, Youth and Families (St. Ann's) under the current RCC contract that expires on 9/30/2013. One with a two-year old child and a three-month old baby had a tumultuous and transient lifestyle and has been at St. Ann's since April 2013. She was unsuccessfully placed at four different RCC locations for numerous reasons such as being absent without leave (AWOL) for days at a time, oppositional defiant, stealing, lying, and refusing to attend school. The other at-risk teen is currently pregnant and had seven unsuccessful placements due to her mental health, noncompliance, aggression, AWOL, and truancy issues. She was on medication for her disorder; however, because she is six months pregnant, she is not taking her medication. She has also been at St. Ann's since April 2013.

St. Ann's is the only RCC Provider with a Teen Mother Program in the State and has shown considerable results in stabilizing such behavior as mentioned above. Therefore, it is in the best interest of the children and the State not to disrupt the current placement or change the existing provider for these two at-risk teens. The procurement method used for this contract is Sole Source under COMAR 21.13.01.06C (1) (b) which supports the decision of Sole Source for continuity of care.

RCC programs are defined in COMAR 14.31.02.03B(13) as "a program of care provided in a residential setting by a provider on a 24-hour basis within a structured set of services and activities." COMAR 14.31.06.01 articulates the standards that must be met and maintained by residential child care programs for children and youth. These requirements are designed to protect the health, safety, and well-being of children placed in residential child care programs.

The State Finance and Procurement Article Section 13-106 and COMAR 21.14.01.04 (Non-Competitive Negotiated Procurement of Human, Social or Educational Services) provide for procuring certain human, social and educational services through a non-competitive negotiated process. The service provider in this request was obtained through this process.

The Governor's Office for Children is the single point of entry for private providers interested in supplying care under approved negotiated rates for youth of the various State agencies. These providers have rates that have been approved by the Interagency Rates Committee (IRC).

Because this contract is only for five beds, it does not meet the criteria for the 5% MBE participation goal that all foster care/per diem contractors who have a capacity, as approved by the IRC or the Maryland State Department of Education, of 25 or more beds across all programs to have a MBE participation goal.



REQUESTING AGENCY REMARKS: In September 2012, DHR issued a Request for Proposals (RFP) to obtain Residential Child Care (RCC) services in seven distinct program categories: Developmentally Disabled, Diagnostic Evaluation and Treatment, Group Home, High Intensity Group Home, Medically Fragile, Psychiatric Respite and a new program for Teen Girls with Anti-social Behaviors. New RCC contract award recommendations were approved by the Board of Public Works (BPW) at the 6/12/2013 BPW meeting (DBM Item 8-S). The Medically Fragile (MF) RCC program only received one proposal for the RFP that was determined not to be reasonably susceptible of being selected for award. The three existing RCC providers for medically fragile group home services failed to submit proposals within the time allowed for the RFP. These three contracts were extended for a six month period [DBM Item 4-S-MOD (3/6/2013)] to allow DHR time to conduct a new procurement via a Request for General Expressions of Interest (RGEI) in accordance with COMAR 21.14.01.04 (Non-Competitive Negotiated Procurement of Human, Social or Educational Services).

A notice of the availability of the RGEI was advertised on *eMaryland Marketplace* and the DHR website. A copy of the notice was sent directly to four prospective offerors, all of which are Maryland firms licensed by the Department of Health and Mental Hygiene's Office of Health Care Quality to provide medically fragile group home services, including one certified MBE.

All four offerors responded to the RGEI and are being recommended for awards, as their offers were all deemed acceptable based upon discussions and past experience in delivering MF services to DHR's children/youth. These MF RCC contract awards are deemed to be in the State's best interest.

The MF program provides specialized care for children who have debilitating or life threatening medical conditions and/or pervasive developmental delays that require specialized care. Many of the children have multiple disabilities and may be dually diagnosed with emotional and/or behavioral disorders.

The four MF RCC contracts will provide 62 beds Statewide. The providers' services will be used at the sole discretion of DHR; and DHR makes no guarantee as to the number of children/youth to be placed with any provider. All four providers have rates approved by the Interagency Rates Committee (IRC), and are paid solely for the actual number of children placed in their care during the year, and then only for the actual days the children are with the contractors.

ITEM: 4-S (Cont.)

The standards that must be met and maintained by residential child care programs for children and youth are delineated in COMAR 14.31.06.01. These requirements are designed to protect the health, safety and well being of children placed in residential child care programs.

COMAR 14.31.02.03B(13) defines RCC programs as "a program of care provided in a residential setting by a provider on a 24-hour basis for longer than 24 hours to a child or children unless otherwise provided by State law."

One offeror met the criteria for inclusion of a 5% MBE subcontracting goal as established by DHR. The criteria requires that all foster care/per diem contractors who have a capacity, as approved by the IRC or the Maryland State Department of Education, of 25 or more beds across all programs to have a MBE participation goal.

The short contract term was established to line-up these four MF RCC contracts with the other RCC contracts that were awarded in June 2013.

REQUESTING AGENCY REMARKS: A notice of the availability of the Request for Proposals (RFP) was advertised on *eMaryland Marketplace*. A copy was also sent to the Governor's Office of Minority Affairs.

Two proposals were received in response to the RFP. Both were deemed to be reasonably susceptible of being selected for award. The proposal from The Bode Technology Group, Inc. was determined to have the more advantageous offer to the State with the higher ranked technical proposal. The slightly lower price (\$1,595 or 1%) of the #2 ranked technical offeror did not offset the technical differences between the two. Therefore, The Bode Technology Group, Inc. is recommended for award.

The success and continuation of the CODIS DNA Database is dependent upon the quality of the database, namely the accuracy of the data entered. The integrity of the program is crucial to the investigation of criminal cases. A reported error that resulted in the arrest of a wrongly accused individual or the release of the actual perpetrator would jeopardize the future of the CODIS DNA Database. It would further put into question the quality assurance program of the entire FSD as well as create doubt for evidence presented in court.

The *Award Amount* and the *Offer Amount* (Evaluated Financial Price) shown are different. The *Offer Amount* was based upon a weighted pricing model for different types of tests to be performed. The *Award Amount* is based on funding and historical usage. This is an indefinite quantity, fixed unit price contract. The Contractor will be paid the individual prices for the different tests as submitted on the financial proposal.

No MBE participation goal was established for this contract because of the limited subcontracting opportunities and the chain of custody issues that do not allow subcontractors to perform the direct services in this contract. In addition, a search of Maryland Certified MBEs to perform these services found that none were available.

DHCD's EmPOWER Low Income Energy Efficiency Program (LIEEP) provides weatherization services for limited income, single-family housing units located within the State of Maryland and within the five EmPower partner utility service regions: (1) Potomac Edison, (2) Baltimore Gas and Electric, (3) Delmarva Power, (4) Potomac Electric Power Company, and (5) Southern Maryland Electric Cooperative, Inc. Clients served include both owners and renters who meet income eligibility requirements.

It is in the best interest of the State to exercise the first renewal option to maintain the State Weatherization Contractors (SWCs) to ensure continued production volume and work quality and to protect DHCD's investment in the SWCs' intensive six-month start-up education and training. Also compensation to the SWCs is based upon a not-to-exceed per housing unit rate established by DHCD and agreed to by the SWCs, so financial pricing would not affected by conducting a solicitation for a new contracts.



REQUESTING AGENCY REMARKS: Originally, three contracts were awarded to ensure the availability of peer reviewers to conduct physician peer reviews and to provide expert opinions, consultations, and witness testimonies, in order to assist the Maryland Board of Physicians (Board) in investigating and taking, where necessary, appropriate disciplinary action against physicians who are the subjects of allegations involving Health Occupations Article, Section 14-404(a) (22). This contract allows the Board to carry out its mission of public protection.

Two contractors, Permedion, Inc. and Maximus, Inc., were providing the entire group of 43 specialties; whereas one contractor, American College of Emergency Physicians (MD Chapter), only provided two specialties.

Maximus, Inc. made a settlement agreement with the Board in September 2010 for \$400,000 to recover funds paid without performing services as prescribed by the contract. The settlement funds are in the Board's carryover account but cannot presently be used because the contract was never modified to increase the NTE amount. The Board has exhausted the funds approved for the contracts and needs a modification to be able to use them to pay Permedion, Inc. for services.

As a result of the default by Maximus, Inc., the Board was required to have peer reviews redone, thus causing a delay in the process. This created a backlog of investigations which resulted in a deficiency as described in the 2011 Sunset Review. It took additional funds from the current contract to expedite the reviews to reduce the backlog. The Board is requesting to use the settlement funds (currently placed in its carryover account) to modify the contract in the amount of \$400,000. This modification will allow the Board to have enough funds to continue peer reviews until the contract end date.





REQUESTING AGENCY REMARKS: The Maryland State Police is requesting ten Pilot I positions to be used to transition to the new AW 139 helicopters. Since delivery of the AW139 in late February, a significant amount of operational experience in the helicopter has been gained by the Aviation Command. Based on this experience the command made a decision that the AW139 helicopter will be operated with two (2) pilots at all times. The decision was based on the following: Increased cockpit workload due to the complexity of the aircraft systems on the AW139; significantly larger aircraft as compared to the Dauphin; industry best practice as all other operators of the AW139 (except one) in the U.S. fly with 2 pilots. In order to mitigate risk and operate the AW139 in safest manner possible; comply with the recommendation of the Part 135 consultant retained by command; ensure effective crew resource management due to the interior wall design of the new aircraft the addition of a second pilot is necessary. The FAA has placed an "SIC Required" limitation on the license of MSP pilots as they complete their initial "Type Rating" training at Rotorsim. These additional positions will be needed to operate the AW139 under FAA licensure when passengers are onboard the aircraft. The Aviation Command will require these pilots to fully transition all of the seven statewide sections.

The contract includes installation of a mechanical system at the World Trade Center referred to as the Harbor Heat Sink consisting, in general, of heat exchangers, pumps, and other equipment to circulate water from the Inner Harbor to cool condenser water from the chillers. The Harbor Heat Sink is innovative technology that will replace outdated and less efficient cooling towers. When the original contract was approved, the design of the Harbor Heat Sink was not complete. However, it was imperative the contract proceed in order to meet a deadline on the use of Federal funding in the solar portion of the contract (installed at the South Locust Point Cruise Terminal). Subsequent completion and refinement of the design of the Harbor Heat Sink after award of the contract showed that certain changes to the Harbor Heat Sink are desirable. Those changes will increase the contractor's cost to construct the Harbor Heat Sink beyond those the contractor included in its contract price. However, those additional current capital construction costs are partially offset by savings in future operating costs payable to the contractor for operations and maintenance costs and measurement and verification costs associated with fulfillment of the contractor's guarantee of future energy

savings (with no decrease in the services to be provided by the contractor). To further offset the additional costs of constructing the redesigned Harbor Heat Sink, MPA and the contractor agreed to eliminate insulation in Buildings 91A and 91B at Dundalk Marine Terminal because it would provide only marginal future energy savings. These offsets result in MPA and the contractor being able to implement the redesigned Harbor Heat Sink at no net change to the overall contract price, no net change to the beneficial environmental impact of the project, and no significant reduction in the future energy savings guaranteed by the contractor. This Modification will also extend the date for completion of the construction phase of the contract from January 6, 2013 (18 months from July 6, 2011) to March 28, 2014.







One (1) submission was received on August 8, 2013. The Procurement Officer surveyed several companies who downloaded the solicitation documents to inquire as to why they did not submit a bid for this project. Responses included: lack of experience; conflict with other projects; not a good fit; too busy or not qualified. The Procurement Officer determined that the other bidders had an equal opportunity to respond.

The Evaluation Committee met on August 13, 2013 to review the one submission for acceptability. Clarifications were requested and received by the Procurement Officer, resulting in the one submission being declared acceptable. In accordance with the IFB document, the Price was opened. The price exceeded the available funding for this project.

In accordance with the Procurement Officer's Determination, dated July 5, 2013 which justified the use of the Design/Build method of procurement for this project, Federal Funds available at this time will be lost if an award is not made by the September 2013 deadline. Therefore, the Procurement Officer, in accordance with COMAR 21.05.04.01A(2), determined that it is in the State's best interest to proceed with Procurement by Negotiated Award After Unsatisfactory Competitive Sealed Bidding.

On August 14, 2013, a recommendation to reject the price bid and proceed with negotiations with the single bidder was prepared. Due to time restraints, the Procurement Officer contacted the bidder to confirm the bidder's desire to proceed with negotiations and subsequently requested a detailed breakdown of the Base Bid Price.

The Committee, consisting of Project Management and Military staff met on August 16, 2013 to review the cost breakdown submitted and to discuss possible value engineering efforts. A conference call was scheduled with the Committee and pertinent parties from WM Schlosser to discuss further value engineering efforts. The meeting resulted in an agreement to a reduction in the work of the contract. The contract includes site work, storm water management, demolition of existing firing line roof, construction of a 4-lane firing range that is a fully baffled containment structure, design and construction of a 144-SF control building, and expansion of an existing rifle range. There are alternates that would add up to 4 lanes to the fully baffled range, another control building, two ammo breakdown buildings, covered mess structure, covered bleacher enclosure, rigid concrete paving and renovations of existing bleacher enclosure.

REMARKS

Subsequent to abandoning the initially

proposed new 180-bed YDC project, DPSCS has reassessed the youth population projections based on the recent declining population figures and has now planned for a downsized 60-bed facility by renovation of the existing BPRU and OSTC instead of the new Youth Detention Center in the Baltimore Correctional Complex. The General Assembly, in its 2013 session, proposed and authorized the Capital Funds in the amount of \$2,600,000 for the design of the 60-bed facility project. The revised project program for the renovation for 60-bed facility prepared jointly by Department of Juvenile Services (DJS) and DPSCS was approved by Department of Budget and Management (DBM).

The proposed 60-bed facility by renovation of BPRU and a portion of OSTC will be 59,347 GSF and will provide spaces for housing, education, administration, program services (counseling, drug treatment, etc.), visitation, medical, recreation, and food services.

REMARKS

The three phases of design and construction of the BCCC main building complex began in 1999 and originally were scheduled to be completed in 2005. Subsequent delays in funding and limited appropriations resulted in the need to re-program functional spaces within the administration wing due to operational changes at the College, and insufficient funds to fulfill the original contract fee obligation. BACKGROUND

The State granted the *Addiction Referral and Counseling, Inc. (now Baltimore Community Resource Center, Inc.)* \$175,000 in general-obligation bond proceeds for acquisition and renovations of a three story office building located at 21 West 25th Street in Baltimore City, as follows:

\$175,000

Community Mental Health Components, Addiction Facilities and Developmental Disabilities Loan of 1989.

In connection with the grant, the Deed dated February 22, 1988 and recorded among the Land Records of Baltimore City in Liber S.E.B. No. 1824, Folio 513 was amended on November 8, 1990 in compliance with the conditions established by the State of Maryland in the Notices of the State's Right of Recovery, as required under *Health General Article 24-606*.

Baltimore Community Resource Center, Inc. is refinancing its existing debt held by Midstate Community Bank, successor to Midstate Federal Savings and Loan Association (hereinafter referred to as "Lender") with a term loan of \$672,663. The refinancing will be provided by Midstate Community Bank and secured by a deed of trust in favor of Midstate Community Bank. The Lender is unable to substitute the collateral as security for the Financing unless the State agrees to subordinate its legal and equitable rights under the Declaration to the lien of the Deed of Trust in the amount of \$672,663.

The Board is now requested to approve a Waiver of Priority Declaration and Subordination Agreement that will permit Baltimore Community Resource Center, Inc., to close on the loan. A DHMH Assistant Attorney General has reviewed and approved the Waiver of Priority Declaration and Subordination Agreement for legal sufficiency. The Department of Health and Mental Hygiene recommends Board approval.

Health General Article 24-606(f)(2) provides that a lien based on the State's right of recovery is superior to a lien or other interest of a mortgage "except as the State may by written subordination agreement provide otherwise".
