**Remarks:** Reference is made to Secretary's Agenda Item 15 (4/17/13) in which the Board of Public Works approved three Fund Managers for the VLT Account Program in its first year of operation in FY 2014.

- Meridian Management Group Inc. was awarded \$3.5 million in Video Lottery Terminal proceeds of which 92% was to be used to make loans to small, minority, and woman owned businesses across Maryland and up to 8% (\$280,000) could be used as a Fund Establishment Expense Fee in connection with the initial establishment of the Fund Manager's operations.
- Anne Arundel Economic Development Corp was awarded \$3.4 million in Video Lottery Terminal proceeds of which 92% was to be used to make loans to small, minority, and woman owned businesses across Maryland and up to 8% (\$268,800) could be used as a Fund Establishment Expense Fee in connection with the initial establishment of the Fund Manager's operations.

Increased allocation for FY 2014 Fund Establishment Expense Fees for one Fund Manager. Shortly after its award, MMG sought an additional \$145,000 for its operating-expenses allocation, increasing the expense fee total from \$280,000 to \$425,000. The Legislative Auditor later found that MMG actually received a total of \$436,000 for overhead and operating expenses. The increase was based on MMG's budget for overhead and operating expenses submitted in MMG's response to the Request for Proposals. The Department of Commerce, acting as an agent for the Board, approved MMG's request without seeking Board approval.

Reimbursements for FY 2015 Excess Expense Fees for two Fund Managers. The State's contracts with MMG and AAEDC allowed them to be reimbursed from the VLT Fund at year's end for the amount, if any, that their program expenses exceeded income. Commerce granted reimbursement requests from two Fund Managers for FY 2015 excess expenses without seeking specific Board approval.

Reimbursement was calculated based on the lesser of: the actual amount of the expenses that exceed income or 5% of the fund balance under the Fund Manager's management at year's end. (Fund balance under management includes the principal of loan assets and the booked value of investment assets outstanding.)

- MMG requested reimbursement for excess fund expenses of \$86,297. This amount is 1.57% of the \$5.5 million under MMG's management.
- AAEDC requested reimbursement for excess fund expenses of \$195,825. This amount is 5% of the \$3.9 million under AAEDC's management.

### 5. **DEPARTMENT OF NATURAL RESOURCES**

Natural Resources Development Fund Bloede Dam Removal

**Recommendation:** That the Board of Public Works approve:

- (1) The Department of General Services delegating procurement authority to the Department of Natural Resources for construction of the Bloede Dam removal;
- (2) DNR using \$1,000,000 in general-obligation bond proceeds to fund an agreement with American Rivers for construction management, an agreement that is exempt from the State Procurement Law as it is a conservation services opportunity (State Finance & Procurement Article 11-203, (a)(1)(xix); and
- (3) DGS transferring the funds to DNR for the construction project.

**Background:** Reference is made to Secretary's Agenda Item 18 (3/6/2013) in which the Board of Public Works approved DNR's supervision of the Bloede Dam removal project. Specifically, the Board approved: DGS delegating to DNR authority to contract for design services and DNR contracting with American Rivers, a nonprofit entity, for design services.

American Rivers has completed the preparation of construction documents; permits for the construction phase of the project are pending. DNR now seeks to enter into an agreement with American Rivers for the construction phase.

*Objectives*: Bloede Dam is located on the Patapsco River within the Patapsco Valley State Park spanning Howard and Baltimore Counties. DNR, together with several partners, is working to restore the Patapsco River to a more natural, free-flowing condition. Removing impediments to the Patapsco River's free flow, such as Bloede Dam, will achieve three primary objectives:

### • Improvement of Public Safety

The Bloede dam is a significant public safety hazard; several deaths have occurred at or near the dam.

### • Restoration of Fish and Aquatic Organism Passage

The Patapsco River once supported large runs of shad, herring, and American eels, but dam construction blocked these historic migrations. Fish ladders constructed in the 1990s have proven to be ineffective at passing fish, especially American eel.

### • Consideration of Historic, Cultural and Recreational Values

The Bloede Dam was built in the early 1900s with a unique design. DNR has consulted with the Maryland Historical Trust and the community and is completing plans to record and share the history of the Dam via on-site interpretation.

**Public Comment:** DNR conducted a feasibility study of various Bloede Dam options. As part of the study, DNR held an open house in June 2012 and received over 70 written comments during the public comment period. Most of the comments favored the option presented here: removing Bloede Dam with passive sediment management.

American Rivers: American Rivers, a nonprofit entity is experienced in river restoration and dam removal projects. It has pioneered a science-based approach to the removal of outdated dams and other stream barriers that engages communities in restoring their rivers and identifies federal funds to make the removals possible. American Rivers successfully designed and managed the removal of Simpkins Dam on the Patapsco River upstream of Bloede Dam; its efforts have directly contributed to the removal of more than 200 dams across the country.

**Fund Source**: DNR proposes to use general-obligation bond proceeds and grant awards from National Oceanic and Air Administration (NOAA) and the Maryland Port Administration to address mitigation requirements on one of their projects, to fund 17.5% of the construction costs. American Rivers has received grants from NOAA, U.S. Fish & Wildlife Service, the National Fish & Wildlife Foundation, and private grants to cover the remaining construction costs.

### 6. MARYLAND DEPARTMENT OF THE ENVIRONMENT

**Recommendation:** That the Board of Public Works approve further funding up to \$108,937,151 to Baltimore City for the **Back River Wastewater Treatment Plant Enhanced Nutrient Removal Upgrade** project. Funding may involve multiple sources of funding, including general obligation bond proceeds, which may be provided over several years based on project schedule. (Legislative District 6)

- A. Grant Increase (up to) \$85,728,565 Bay Restoration Fund (BR-NR 01.03)
- B. Grant Increase (up to) \$23,208,586 Chesapeake Bay Water Quality Projects Biological Nutrient Removal (NR09.03)

Project Description: The project entails the planning, design and construction of Biological Nutrient Removal (BNR) and Enhanced Nutrient Removal (ENR) facilities at the existing 180 MGD Back River WWTP. The plant is currently achieving better than the ENR goal of 0.3 mg/l for Total Phosphorus, as its discharge permit requires the plant to achieve monthly average limit of 0.2 mg/l for Total Phosphorus. The construction of the BNR and ENR facilities will consist of two phases. Phase 1 will include the upgrade of existing Activated Sludge Plant Nos. 2 and 3, new denitrification filters and chemical storage and feed system. Phase 2 will include the new Activated Sludge Plant No. 4. The BNR and ENR upgrades will allow the plant to achieve effluent concentration goal of 3.0 mg/l for Total Nitrogen which represents an 83 percent reduction in Total Nitrogen discharge. These improvements will reduce nutrients discharged to Back River and ultimately the Chesapeake Bay.

### 7. MARYLAND STADIUM AUTHORITY

Baltimore City Public Schools: Frederick PK-5 School

Contract ID: Frederick PK-5 School/BCS-008

**Recommendation:** That the Board of Public Works approve the award of Bid Package No. 2 to Gilbane Building Company, the construction manager at risk, for the Frederick PK-5 School project.

Contractor: Gilbane Building Company, Baltimore, MD 21230

**Prior Approvals:** Secretary's Agenda Items #15 (12/17/14) and #12 (12/16/15)

**Project:** The Frederick PK-5 School project is a renovation/addition of the approximately 85,000 square-foot school building at 2501 Frederick Avenue.

The Stadium Authority estimated the construction cost to be \$24.6 million. Construction costs of \$24.1 million and contingencies of \$1.03 million are included in the final recommendation to award.

### 7. MARYLAND STADIUM AUTHORITY (cont'd) Baltimore City Public Schools: Frederick PK-5 School

**Remarks:** Reference is made to Secretary's Agenda Item 12 (12/16/15) in which the Stadium Authority stated: "The Stadium Authority anticipates returning to the Board of Public Works for permission to add the remaining construction bid packages to the contract when appropriate. The remaining bid packages are currently out to bid."

Gilbane advertised the remaining construction packages for trade contractor participation in November 2015 on *eMarylandMarketplace*, Gilbane's website, the Stadium's website, Baltimore 21st Century Schools' website, MWMCA's website, and McGraw-Hill. The advertisement stated that bids would be accepted from pre-qualified trade contractors and provided the method for contractors to achieve pre-qualification. Documents were issued for 22 trade packages. Pre-bid meetings were held at Frederick Elementary School. All attendees were provided with summary project information and given an opportunity to tour the site. Gilbane extended the bid dates for several packages to maximize participation from bidders.

In late December 2015, trade contractors submitted sealed bids that were opened publically at Gilbane's Baltimore office; at the bid opening were representatives of the Stadium Authority and Gilbane. Due to a lack of sufficient bid coverage in some of the areas, Gilbane re-issued seven packages for bid in January 2016. For these bid packages, a public bid opening was conducted in February.

Overall sixty-five bids were received for the twenty-two packages advertised.

Post-bid scope review meetings have been conducted with selected trade contractors to ensure that their bids were responsive and complete. These meetings were attended by representatives of the Stadium Authority, Gilbane, and the project architect. All participants have worked diligently to achieve more value in Bid Package #2.

However, at that time there were two youth in the program. Three additional youth were placed between May 2015 and March 2016 also without notification to the SSA CMU. As a result of the additional youth being placed at Woods without being properly added through formal monitoring of the contract and funding, a funding shortfall occurred.

DHR/SSA has developed and implemented a formal monitoring process to ensure that this situation does not re-occur. DHR has revised its internal process for notification when youth are being placed in out-of-state facilities. All notifications regarding youth will be made at the time the Local Department of Social Services (LDSS) submits a request to the SSA Placement and Support Services Unit (P&SSU) for approval of out-of-state placements. The SSA P&SSU is responsible for approving the out-of-state placements for DHR. The SSA P&SSU will notify the SSA CMU of the referral via email. The SSA CMU will conduct a preliminary contract review to include placement and funding to determine if additional funding is required and the appropriate procurement method needed (emergency placement or modification). In addition, the SSA CMU will begin reviewing the payments made to the out-of-state providers on a monthly basis. This will ensure all contracts have sufficient funding for youth placements.

This is a not-to-exceed (NTE) per diem contract where the provider is paid solely per child, per day. As such, DHR will not be charged for any unused capacity.

Residential Child Care programs are defined in COMAR 14.31.02.03B(13) as "a program of care provided in a residential setting by a provider on a 24-hour basis for longer than 24 hours to a child or children unless otherwise provided by State law." In time, the resource library could be expanded to include parents and caregivers to assist them with navigating the laws pertaining to their children.

#### Remarks (cont'd):

The solicitation was posted on *eMarylandMarketplace* under the category of Internet and Web Site software. MSDE believed that this category most closely aligned with the requirements of the solicitation. The Offeror also needed to have knowledge of State and federal regulations and where to find those regulations to compile them in one location for the end user. This was perceived to be much like a subscription service which MSDE staff would log on and use. There was no way to know if there were any offerors with the required skills for this particular service before advertising the solicitation or if MSDE would have to develop this solution at a higher cost to the agency and the State.

One proposal was received in response to this solicitation. MicroScribe has experience in this service having provided the service to other state education entities around the country. The most recent clients include the Michigan Department of Education, the Utah State Office of Education and the California Department of Education. Their "information consolidation services" are used by other state educational agencies as well. This is a vendor hosted solution, accessible via the internet.

A survey of a sampling of potential offerors who did not submit a proposal, including the two firms that attended the pre-proposal conference was taken to determine why no other proposals were received. Answers included "we were unable to respond as we don't provide those services"; "We may have missed the *eMM* posting, we monitor CATS +"; "That is not within our scope of services"; and from a pre-proposal attendee, "We had limited subject matter, domain experience in this field."

The fee is an annual service fee based on the number of Maryland students enrolled in the local school systems. Development costs have been waived and data back-up is included in the price. This will be hosted at the vendor's location and accessible via the internet. MSDE procurement requested comparison pricing to be certain that the State received fair and reasonable pricing.

This unique program is designed to monitor the youth electronically to ensure he/she is abiding by the court ordered conditions. The program requires specialized equipment and monitoring software to ensure that accurate accounts of each youth are maintained. Supervision information occurs in real time with each youth being actively electronically supervised to ensure compliance with their court ordered requirements.

The incumbent, Behavioral Interventions, Inc., received the highest technical ranking. Sentinel Offender Services, LLC submitted an initial bid price of \$1,900,737.50. The incumbent submitted a bid price of \$3,423,152.50. Sentinel Offender Services, LLC then submitted a BAFO in the amount of \$1,856,937.50. Behavioral Interventions, Inc. submitted a BAFO in the amount of \$3,080,052.50. DJS contacted the lowest bidder to confirm the offeror understood the scope of work, verified pricing and certified they can perform on the contract at the pricing quoted.

DJS is recommending award of the contract to Sentinel Offender Services, LLC. The proposal submitted by Sentinel Offender Services, LLC was determined to be the most advantageous to the State, considering price and the evaluation factors set forth in the request for proposals. The program requires specialized equipment and monitoring software to ensure that accurate accounts of each youth are maintained. The Department feels there were limited responses received because two compatible services were needed for an effective program. DJS requested both electronic and voice recognition monitoring; both systems need to be able to operate on the same software platform and interface, allowing the Community Detention staff to manage their youth effectively.

As a result of the awards from this solicitation, State agencies will obtain software, installation, training and maintenance services quickly and efficiently by issuing PORRPs specific to each agency's needs. This Master Contract is available for County and local jurisdictions' uses.

The COTS Master Contract expires July 27, 2027 and for the remaining 11+ years, the State will receive the full benefit of any maintenance agreement associated with PORFPs.

The Board of Public Works previously approved a \$71 million ceiling for the COTS Master Contract. See DoIT Item 6-IT (9/19/12); DoIT Item 12-IT-Mod (8/13/14). The current spend is \$66.5 million. **REMARKS:** In accordance with State Finance and Procurement Article § 10A-203, on November 6, 2013, the BPW approved MDOT/MTA plan to deliver the Purple Line as a Design, Build, Finance, Operate, and Maintain P3, as well as the proposed competitive solicitation method for selecting a concessionaire. MDOT/MTA issued a Request for Qualifications on November 8, 2013 for the P3 and out of six Statements of Qualifications, shortlisted four qualified teams on January 8, 2014. MDOT/MTA released the Request for Proposal (RFP) and Instructions to Proposers on July 28, 2014. MDOT/MTA received competitive and compliant technical proposals on November 17, 2015 and financial proposals on December 8, 2015 from all four shortlisted proposer teams.

An evaluation team was appointed and formed to review and evaluate proposals. The evaluation process spelled out in the Purple Line P3 Solicitation Plan approved by the BPW on November 6, 2013 and the RFP were strictly followed. An Executive Committee comprised of State and County senior level officials presented their recommendation to the Secretary of Transportation of the "Best Value" offer for the State of Maryland. The Secretary concurred with the Executive Committee recommendation and announced that Purple Line Transit Partners is the selected proposer to design, build, finance, operate and maintain the Purple Line project pursuant to the final negotiated P3 Agreement. On March 2, 2016, the P3 Agreement was posted on the Purple Line website. The P3 Agreement and accompanying P3 Report was submitted to the Comptroller, the State Treasurer, the Senate and House Budget Committees and the Department of Legislative Services on March 4, 2016, which began a 30 day review and comment period as mandated by the P3 Statute.

Purple Line Transit Partners submitted a proposal that reflected a technical approach that met or exceeded all requirements in the RFP. Purple Line Transit Partners has an excellent track record of constructing mega projects and brings the requisite experience to operate and maintain light rail

systems. The organizational approach, consistent with the requirements of the Purple Line project, includes an exemplary level of staff experience. PLTP's design philosophy offers a comprehensive and executable approach to project maintenance and handback that also minimizes residential, business and environmental impacts. Their design approach incorporates Alternative Technical Concepts that will enhance constructability. Their systems integration approach is well-defined, comprehensive, and executable to include a full program of systems testing leading to the commencement of operations. Ranking of the financial proposals was based on a computed Net Present Value (NPV). Subsequent negotiations with PLTP, permitted by P3 Statute and Regulations, were completed successfully. Purple Line Transit Partners' NPV was \$490 million dollars less than the next closest financial proposal.

The Purple Line will be an impetus to economic development in both Montgomery and Prince George's Counties and surrounding communities. While the corridor is densely developed along certain segments, there remain plentiful opportunities for additional commercial and residential growth around Purple Line stations.

By improving connectivity and accessibility in the corridor, the Purple Line will have a positive economic impact for Maryland's residents and businesses. MDOT/MTA requests BPW approval of the P3 Purple Line Agreement.
