**Contract Description:** Developmental Disabilities Administration (DDA) utilizes this contract to provide the clinical review for the Health Risk Screening Tool that is included in its waivers.

**Modification Description:** **RETROACTIVE** request to ratify the contract as voidable starting with Modification #1, including all prior modification actions (Modifications #1- #3) and proactive approval of Modification #4. Modification #1 to add funds due to the increased number of reviews for the health risk screening tool. Modification # 2 extension (03/1/2025 - 05/31/2025). Modification #3 extension (06/01/2025 - 07/15/2025). Modification #4 proactive approval to extend the contract to allow time to complete the new procurement.

**Requesting Agency Remarks:** Due to an administrative oversight, Modifications #1- #3 were not brought to BPW for approval. Without the modification, services for the waiver participants would be disrupted. The delay in the new procurement can largely be attributed to a significant turnover within the program unit's staffing. The contract requires the clinical review of the Health Risk Screening Tool for participants who do not have a nurse or another method for getting the review completed. This process is a requirement for all Developmental Disabilities Administration waivers. The delay in awarding a replacement contract is due to several key team members with critical responsibilities in contract oversight and procurement planning either transitioning out of their roles or newly onboarded during the development phase. As a result, there was a noticeable gap in institutional knowledge, particularly in the areas of contract administration and procurement requirements. MDH is working on the new RFP and expects to have it posted by the beginning of August. The timeline for the new procurement is based on recommendations and the length of time that it has from preparation to posting and awarding of the actual contract, and is anticipated to be awarded by Summer 2026.
