Requesting Agency Remarks: The extension is necessary because the award of the solicitation was not put into place prior to the previous extension due to amendments issued that impacted the Financial Proposal and technical proposal responses.

The new solicitation incorporates new services related to the RFP including Post-Guardianship and Post-Reunification services. The modification is necessary to continue providing post-adoptive services without service disruption to children, youth, and families while the new solicitation is completed.

This Contract provides services to children and families who have finalized adoptions within the State of Maryland and prevents disruption and dissolution of adoptions. Families throughout Maryland can self-refer or be referred by local departments to obtain the services offered by the vendor. This contract supports and provides services to Adoptive families and prevent disruptions that will keep children and youth out of care or from re-entering care.

MBE and VSBE participation were not established for this contract because there were no subcontracting opportunities.
