REMARKS: Currently, \$4.3 million of funding is available for the design of the School of Business. The total value of the design contract is \$6,346,500. This cost is within the expected amount for this type of facility when the full scope of work is considered. Currently, there is not sufficient funding to award the full contract. To enable the project to proceed without a significant delay, the University is requesting that the contract be partially awarded for design services from pre-schematic through design development at a cost of \$2,302,255. The University is seeking additional funding during the FY12 Legislative Session to enable the balance of the contract to be awarded in July 2011. The Office of Capital Budgeting and the Budget Committees have been apprised of this requested action.

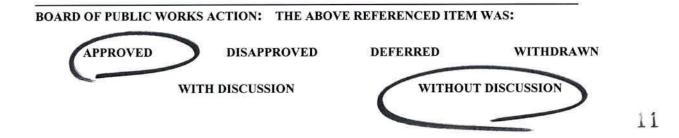

REMARKS: (cont'd) The team of ASG/KPF was selected from a three-step process. Seventeen technical proposals were received and evaluated; six firms were short-listed to make oral presentations; the best team (the team with the highest combined technical and oral score) was requested to submit a price proposal. Negotiation of the price proposal took place reducing the initial price request by almost \$1million, by clarifying/fine tuning the scope of work and schedule.

The ASG/KPF team includes 17 sub-consultants with 14 sub-consultants from Maryland and will employ approximately 34 persons throughout the project. The Morgan State University Department of Design and Construction Management will manage the AE teams work with procurement support provided by the University's Department of Procurement and Property Control.

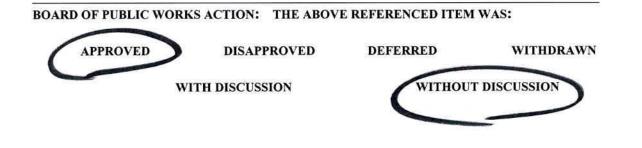

The State Treasurer recommends that the Board of Public Works approve the award of the November 2010 Energy Performance Contract Lease-Purchase Financing Agreement for financing the acquisition of certain energy systems and equipment by the Maryland Aviation Administration. This November 2010 Energy Lease will provide financing for \$17,482,889.98 in equipment purchases and related facility energy improvements for the MAA at BWI Marshall and Martin State Airports. The Board previously approved the award of Phase II of an Energy Performance Contract between MAA and Pepco Energy Services, Inc. which contemplated this energy-lease financing. 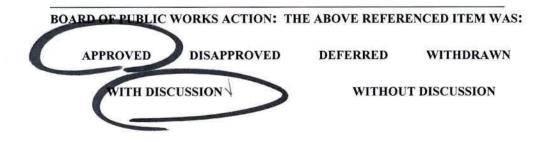
7. <u>STATE TREASURER</u> (cont'd) November 2010 Energy Performance Contract Lease-Purchase Financing

REMARKS: The State Treasurer's Office issued an Invitation for Bids on October 7, 2010, for financing on a consolidated basis \$17,482,889.98 in energy systems or equipment; published it on *eMarylandMarketplace;* posted on the websites for the National Association of State Treasurers and the State Treasurer's Office; and emailed to 30 firms known to be active in financing municipal leases. The lease financing is expected to close no later than November 18, 2010. The bids were evaluated on the lowest fixed interest rate on the actual amounts to be financed from11/18/2011 to 7/1/2025.

Reference is made to DOT Item 1-C (9/1/10) in which it is stated that Pepco Energy Services, Inc. guarantees that the MAA will realize a total annual savings of \$2,055,251 per year for fifteen years and will provide MAA with a renewable one year energy savings bond as a guarantee of the energy savings. The winning bidder's debt service payments per fiscal year total \$1,600,406.

As described in Secretary's Agenda, Item 14 (10/21/09), because of market volatility, the State Treasurer's Office determined to solicit new energy lease financing bids every two months or as necessary to meet actual energy lease financing needs, rather than use a long-term Master Lease. This Agenda Item represents the third such financing.

Following the November 2010 Energy Performance Contract Lease-Purchase Financing, the remaining balance of the \$200 million originally approved by the Legislative Policy Committee and the Board for energy lease financing will be approximately \$160.3 million.

REMARKS:

Nature of Emergency: The backlog developed from a slow steady increase in demand for microscopic tissue slide requests made on the histology department. The problem started in February 2009 when a lab assistant resigned and the OCME had substantial difficulty in getting approval to hire another person. When fully staffed, the histology department has three employees who produce over 11,000 tissue slides annually; with the lab assistant's departure, only two employees are available for this work. Further, a 2009 Supreme Court decision changed the way and type of information that medical examiner offices forward to State's Attorney offices. At the same time Public Defender offices increased the number of subpoenas for copies of full case records including recuts of tissue slides for their own experts to review. Each of these things had an impact on the department, adding to backlog and delaying critical information from being given to the medical examiners. Short staffing is also a problem because medical examiners are required to finish cases within 90 days or OCME faces a phase II violation by NAME and risks losing its accreditation.

Basis for Selection: The Aperio is the only complete and integrated solution for digital pathology. This instrument is US made, based in California with local support available in Maryland. Similar equipment is installed at University of Maryland Medical School and at JHU Medical School. The Aperio is the only instrument offering line scanning technology, fully licensed, and owns the intellectual property to offer this technology. This device does not use Bayer Mask color interpolation, and automatically self-calibrates for each slide without manual intervention. Further, this instrument offers integrated image file management software for digital slide organization, searching and report creation. Total cost of ownership is preferred due to the lower service agreement fees. Parts and maintenance services are available locally. The decision was based upon the following criteria:

(5) The proposed solution must offer integrated image file management software that allows for logical digital slide organization, searching, and report creation.

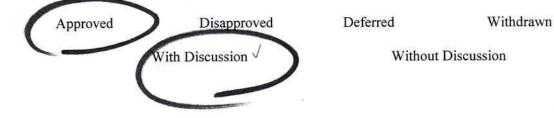

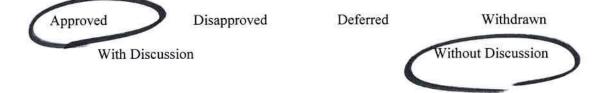

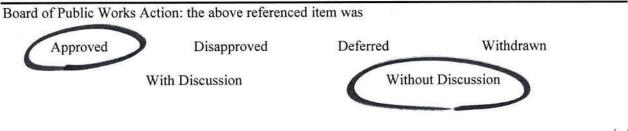

The purpose of this contract is to provide genetic testing laboratory services to establish paternity in contested child support cases in 15 jurisdictions of the State: Allegany, Anne Arundel, Baltimore, Caroline, Cecil, Dorchester, Garrett, Howard, Kent, Montgomery, Prince George's, Washington, Wicomico and Worcester Counties and Baltimore City. The genetic testing laboratory services include the collection of specimens, testing and reporting of findings by a certified laboratory for the 15 local offices. Additional specimen collection and testing of incarcerated obligors is required, as requested, and coordinated by the local office's genetic testing liaison. Services also include the provision of expert witness testimony, if required by the court. These services benefit the Agency by assisting in accomplishing its goal - to quickly and accurately resolve the issue of paternity for non-custodial parents and establish support orders for children.

Genetic testing services for the remaining nine jurisdictions (Calvert, Carroll, Charles, Frederick, Harford, Queen Anne's, St. Mary's, Somerset and Talbot Counties) are provided through each of the jurisdictions' respective State's Attorney's Office. However, any of these jurisdictions may be added to this Contract during the contract term at the request of the county government and its respective State's Attorney's Office. If the addition of any of these jurisdictions causes the spending authorization to be exceeded such that BPW approval is needed for an increase in the funding amount, a BPW agenda item will be submitted at that time.

No MBE participation goal was established for this contract based upon the guidelines that the Contractor must be able to, at a minimum, comply with accreditation standards for parentage testing related to collecting, testing and reporting findings of specimens. These standards have very specific quality control requirements to ensure the highest level of responsibility and accountability rests with the testing laboratory. Included in the published standards are process control procedures that affect the quality of services provided by the testing laboratory, which

Copies of the solicitation notice were emailed directly to 10 prospective vendors, three of which are Maryland firms, and two are MBEs. A copy was also sent to the Governor's Office of Minority Affairs.

A total of eight proposals were received in response to the RFP. Of the eight proposals received, one was an alternate proposal. Five proposals were determined to be reasonably susceptible of being selected for award. The other three proposals, which included the alternate proposal, were rejected due to improper MBE form submissions.

Award is recommended to MHM Maryland, Inc. (MHM) because it was overall ranked #1. MHM had the highest ranked technical proposal of all five Offerors. Even though MHM had the third lowest price, its technical proposal clearly demonstrated its ability to provide the required mental health treatment services through its prior experience with juvenile and adult populations and a multi-vendor model of care better than the lowest priced Offeror and the second lowest priced Offeror. Neither the lowest priced offeror, Hope Health Systems, Inc. (Hope), nor the second lowest priced offeror, STG International, Inc., had the level of experience that MHM had to meet the needs and requirements of DPSCS. The 2.27% difference in price from Hope and the 1.37% difference in price from STGI did not outweigh the years of experience and expertise that MHM would provide.

MHM submitted a strong proposal which fully and directly addressed all requirements of the RFP, showing that it had the most effective treatment centered protocols on primary treatment of the mentally ill inmate population, which included counseling, follow up, proven treatment modalities for specific types of mental illness as diagnosed and presented. MHM demonstrated a detailed understanding of the needs and challenges associated with the correctional population through its experienced operation team, along with sound orientation and training of its staff.

MHM has over 28 years of experience in providing specialized behavioral health services to correctional facilities. It has contracts that include behavioral health programs to state departments of correction, municipal jails, juvenile justice agencies, and court forensic services. In addition to being the incumbent, MHM currently serves over 16,000 jail inmates in Atlanta, Philadelphia, and Salt Lake City.

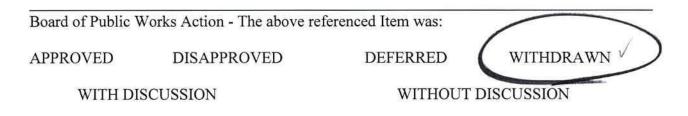

The slight difference in price between the #1 and #2 overall Offerors did not account for the technical differences of the two Offerors. Wexford's technical offer demonstrated its ability to provide the required medical health services/utilization services through its prior experience providing medical health services to inmate populations in other states. Wexford's technical proposal highlighted its superiority by providing a very detailed implementation plan for the delivery of medical services. This plan included a detailed narrative addressing the scope of work, flowcharts, timeframes, and the preparation for full implementation of medical services.

This contract is to provide inmate medical health care/utilization services for the DPSCS. The contract will allow the Department to provide routine, specialty, inpatient and emergency care services, as well as provide a comprehensive, patient centered/case management health care delivery system for DPSCS, Baltimore City pretrial and Maryland's sentenced populations.

CDA also has the highest level of experience in the delivery of correctional dental services among all four Offerors. CDA has the most viable recruitment and retention plan; staff orientation and training programs; and a comprehensive, detailed disease prevention program.

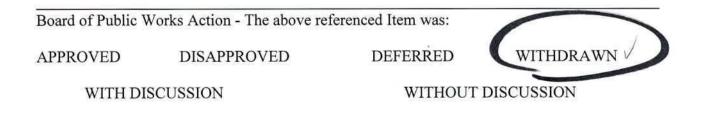

REQUESTING AGENCY REMARKS: The Elementary and Secondary Education Act (ESEA) of 2001 known as the No Child Left Behind Act of 2001 [section 1111(b)(7)] requires state education agencies to ensure that local school systems annually assess the English proficiency of all limited English proficient children in the domains of listening, speaking, reading, and writing. This contract, awarded through a competitive procurement process in 2006, is for the purchase of assessment materials, training, scoring, and reports for the assessment of approximately 48,500 English Language Learner (ELL) students enrolled in grades K-12 in Maryland schools. This 5 year contract expires on December 31, 2010; however, an impending reauthorization of ESEA brings with it new priorities and conditions that will impact the ELL assessments and must be met in order to receive federal funding. Anticipated changes that would effect the new solicitation include:

- New Common Core Standards and Assessments
 - The final Common Core Standards for English language arts and mathematics will be released by the National Governors Association Center for Best Practices (NGA Center) and the Council of Chief State School Officers (CCSSO) in late spring 2011.
 - Maryland is one of 48 states that will align current state curriculum documents with the Common Core Standards.
 - New statewide assessments to measure revised curricula (Common Core) are anticipated to be in place by 2014.
- English Language Proficiency (ELP) Standards and ELP Assessments according to the US Department of Education:
 - Once states adopt college-and career-ready academic content standards, they will need to revise their current ELP standards to link them to these new content standards.
 - o States then will have to align their ELP assessments with these new ELP standards.

The purpose of this modification is to request a one-year extension of the current contract with CTB/McGraw Hill for the ELP assessment in order to allow time to review the new common core standards, revise MSDE standards accordingly, examine the options available for the ELP assessment that meet the changing criteria before going out with a procurement for a new contract that will include all the new requirements. Without the extension, MSDE runs the risk of not meeting federal criteria by adopting an assessment that does not align with the new core standards and the new ELP standards, as required in the reauthorized ESEA, which has not yet been approved.

There was no MBE goal established for this contract because this was an off the shelf assessment tool with no subcontracting opportunities.

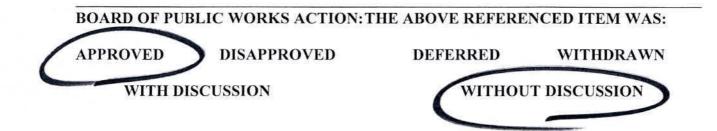

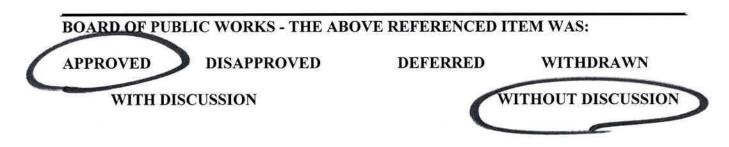

BACKGROUND: In January 2010, the National Institute of Standards and Technology awarded a grant to the University of Maryland, College Park that provided \$10,346,123 in federal funds for the 21,857 gross square foot Laboratories for Advanced Quantum Science to be located at the Physical Sciences Complex. The grant required UMCP to sign and record a Covenant of Purpose, Use, and Ownership that restricts UMCP's use of the Physical Sciences Complex and limits the ability to transfer or mortgage the Physical Sciences Complex without either repaying the federal grant or obtaining NIST's permission. See USM Item 10-GM (7/28/10). After the Covenant was recorded, NIST's legal counsel was concerned that this federal grant could create an Establishment Clause issue if the Physical Science Building, improved with federal monies, were used for an "inherently religious" purpose. While UMCP agrees that it would be unconstitutional for a public university to use this science facility for an inherently religious purpose, NIST insists that the Covenant be formally amended. The amended covenant bars the University from using the property improved with federal monies for any "inherently religious activities" for so long as such improvements have value. The amendment also now describes the affected property by use of a formal metes and bounds legal description.

REMARKS: The original CATS 1 Contract was approved by the BPW on 12/14/2005 (DBM Item 8-IT). The successor contract CATS II was approved by the BPW on 5/20/2009 (DoIT Item 3-IT) and became effective on 6/01/2009.

The large majority of the CATS I task orders needing to be recompeted under CATS II or alternative vehicles have been completed, with the rest under way in various stages of completion. Due in large part to an overall drain on procurement and evaluator resources Statewide, an extension of one calendar year for the CATS I master contract end date, combined with specific task orders extensions, are needed to allow sufficient time to complete the procurement processes and/or transition periods. Most of the task orders being recompeted are for ongoing maintenance and operations support.

The CATS I Master contract had a 30% MBE Goal. The combined awards to MBE prime contractors and MBE subcontractors has been in excess of 52% on the CATS I contract. In addition Small Business awards have been in excess of 22%.

REMARKS: A notice of the availability of the Request for Proposals was advertised on *eMarylandMarketplace.com* and the DoIT website. Through *eMarylandMarketplace.com*, 96 prospective firms were solicited. In addition, 69 firms that were known to have offered similar services were emailed the RFP directly. Of these firms, 20 are certified Minority Business Enterprises and 43 are Maryland firms. A copy of the RFP was sent to the Governor's Office of Minority Affairs.

DoIT received three proposals. One proposal was deemed not reasonably susceptible of being selected for award. The remaining two proposals were evaluated. The Motorola, Inc. proposal was ranked number one technically and number one financially. Therefore, Motorola's overall proposal was determined to be the more advantageous offer to the State.

In the past, jurisdictions and agencies have built stand alone systems that met individual agency needs. However, the deployment of independent non-integrated systems throughout the State (owned and operated by State, county, and local agencies) has created situations that hamper cross-jurisdictional and cross-discipline (*e.g.*, police, fire, EMS, transportation) communications. In Maryland, radio communication interoperability among State agencies and localities is hampered by the use of different operating frequency bands, technologies, and system architectures. These systems are generally voice only and do not support mobile data applications.

This new system will provide interoperable communications. This is the ability for first responders to transmit voice and data communications seamlessly and in real-time, when needed, regardless of agency or jurisdictional boundary. When communications systems are interoperable, police and firefighters responding to a routine incident or a catastrophic emergency can talk to and share information with each other to coordinate efforts and work effectively together.

REMARKS: (cont'd)

Many State agency voice systems will need to be replaced within the next five years as they reach the life-cycle end and must meet the FCC narrow banding deadline. The State will implement this enterprise solution by the Statewide public safety wireless communication system that supports: operable and interoperable public safety voice, low speed data communications, and Homeland Security. The State will use this integrated Statewide public safety wireless communication system as the primary radio communication system for State agencies. Local and municipal first responders may also use the system for primary radio communications. The system will provide voice and low-speed data interoperability among its primary users and other public safety agencies to support Day-to-Day, Mutual Aid, and Task Force operations.

For this contract, it was determined that subcontracting opportunities were available in computer/ telecommunications equipment installation, in tower construction, in tower equipment installation in field staging and in system testing. The MBE participation goal of 12% was determined based upon analysis of the available subcontracting opportunities for these types of work. The contractor has committed to 13.04% MBE participation.

ARINC Inc protested the initial award of this procurement. On March 5, 2010 and March 10, 2010, ARINC Inc. sent protest letters to the State. On April 2, the State of Maryland denied the ARINC Inc. protests. On April 12, ARINC Inc. filed an appeal with the Maryland State Board of Contract Appeals (Docket No. MSBCA 2707). On October 7, the MSBCA granted the State's motion to dismiss the appeal.

In January 2004 the Board of Public Works

approved a competitively bid contract for the development of a Secure State ID System. In conjunction with the issuance of a new State ID and the system to produce the badges, DGS significantly upgraded the electronic security systems of all State facilities. To meet this requirement the contractor designed a system comprised of a centralized enterprise access control system with a server located in Annapolis with a redundant backup server in Baltimore.

To meet certain requirements of the DGS specification and to ensure the integrity of the card encoding, specialized software was developed to further secure the new State credential system. This system was installed in the summer of 2005.

Since that installation the system has been deployed to all DGS controlled facilities and this capability has been adopted by over thirty State agencies.

DGS has determined the technology deployed with the universal State ID card and the universal access control system will remain the State-of-the-art for securing State facilities for the next five years. Therefore, it is critical to the mission of DGS and to the State of Maryland this sole source contract be awarded.

Not awarding this contract as a sole source will be very costly to DGS and the State of Maryland. Over the past five years the State has spent approximately \$10,000,000.00 utilizing the same ID card at facilities around the State.

ETC is in agreement that all current product and labor pricing for each task will remain in effect for the first twelve months of this contract. At the anniversary of each year, all product pricing will increase by the PPI Index amount not to exceed 3% and the approved labor rates.

Although this is not a Statewide contract other State agencies may use this contract in accordance with the same terms, conditions and price.

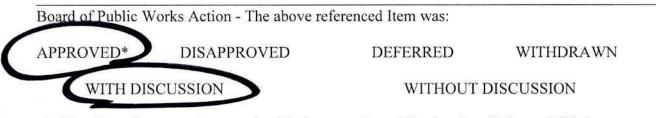

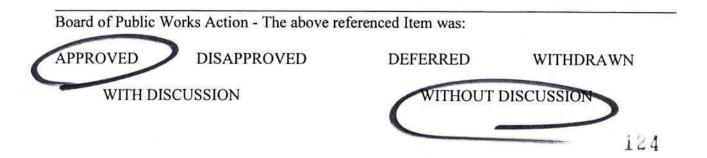

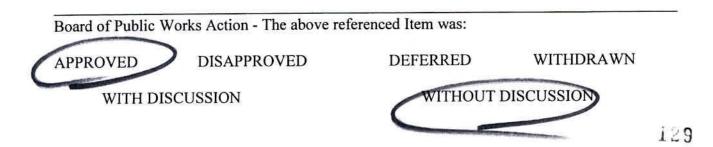

In accordance with Subtitle 6 of the Health-General Article of the *Annotated Code of Maryland*, the Board's approval is further contingent upon the State's right of recovery being included in the Deed(s) or otherwise recorded among the Land Records of Carroll County.

No State funds will be disbursed until the grantee has presented suitable evidence to the Comptroller that it has expended the required matching funds for this project. After the grantee has met this requirement, all future invoices will be submitted to the Comptroller, who will disburse the State portion in amounts equal to the invoices submitted.
