(2) (i) after the initial payment under item (1) of this subsection, installments paid over a period not to exceed 6 fiscal years; or (ii) in accordance with an expedited payment schedule recommended under subsection (d)(1)(iv) of this section.”

3. **BOARD OF PUBLIC WORKS** (cont'd)

Remarks: Conviction. In 2006, Mr. Rodney Brown was convicted in Baltimore City Circuit Court of first- and second-degree assault, and two related handgun charges, arising from the death of an individual.

Release. In 2008, the handgun convictions were overturned by the Court of Special Appeals, as the ballistics did not indicate whether the cartridges used in the crime were fired from a handgun or a long gun. In 2021, following an Order for Post-Conviction DNA Testing, the Circuit Court ordered a new trial; and subsequently the State's Attorney dismissed the assault charges.

Actual Innocence. After three days of proceedings at the Office of Administrative Hearings, the Administrative Law Judge found the "Claimant's alibi witnesses and the Claimant himself to be credible. His evidence was effectively unimpeached by the State's Attorney," and that the key elements of the case in the original prosecution were not credible. Pursuant to SFP § 10-501(b)(2)(ii), the Administrative Law Judge held "the Claimant has shown by clear and convincing evidence that he is actually innocent of the felony he was previously convicted of committing."

Compensation. The Administrative Law Judge found that: (1) Mr. Brown was confined for 5,590 days but that this should be offset by a separate, yet concurrent confinement for an unrelated conviction of 1,461 days, making for a compensable 4,129 days, (2) the current annual income figure to use for calculating compensation is \$87,063, and (3) under the statutory formula, Mr. Brown is entitled to \$984,890.37 in compensation.

Recommended Expedited Payment Schedule. Under SFP § 10-501(d)(1)(iv), if an Administrative Law Judge determines it is in the interests of the exoneree, they are to include a recommendation for an expedited payment schedule in their order. Accordingly, "Based on the interests of the Claimant, including his time wrongfully incarcerated, his current financial need, his age (42 years old), his efforts to exonerate himself, and his overall need..." The decision *In the Matter of the Wrongful Conviction of Rodney Brown, Claimant v. Board of Public Works* recommends an expedited payment schedule over approximately 2.3 years (the statutorily required payment of \$87,063 within 60 days of the decision; \$100,000 by December 31, 2022; \$199,456.84 by June 30, 2023, \$199,456.84 by December 31, 2023; \$199,456.84 by June 30, 2024; and final payment of \$199,456.84 by December 31, 2024).

Attorney's Fees. Under SFP § 10-501(d)(1), orders for compensation and benefits shall include reasonable attorney's fees and expenses associated with the action brought under this section. The decision *In the Matter of the Wrongful Conviction of Rodney Brown, Claimant v. Board of Public Works* ordered payment of attorney's fees in the amount of \$61,974.60.

Wetlands Licenses

Recommendation: The Board of Public Works Wetlands Administrator recommends that the Board grant licenses for projects involving filling and dredging in the navigable waters of Maryland.

MDE: The Maryland Department of the Environment concurs with this recommendation.

Authority: Section 16-202, Environment Article, Annotated Code of Maryland: “*The Board shall decide if issuance of the [tidal wetlands] license is in the best interest of the State, taking into account the varying ecological, economic, developmental, recreational, and aesthetic values [the] application presents.*” See also COMAR 23.02.04.

BALTIMORE CITY

22-0090 *CHEVRON ENVIRONMENTAL MANAGEMENT COMPANY* – To remove contaminated sediment, restore bathymetry, and prevent erosion by mechanically dredging an area, partial dewatering dredged material in uplands, transporting contaminated material to an approved facility, placing stone, and constructing a breakwater.

Project: Urban Stormwater Retrofit Public-Private Partnership – Phase 2

Recipient: Prince George's County

Project Description: This project entails the planning, design, and construction of multiple projects that utilize a wide array of structural treatment options ranging from small rain gardens to large urban retrofit solutions involving suburban drain inlet modifications, pond retrofits, County right-of-way Best Management Practices as well as green streets and high-flow media treatment options. These efforts are intended to achieve compliance with the County's Municipal Separate Storm Sewer System Discharge Permit and the Chesapeake Bay Watershed Implementation Plan. The goal is to retrofit or install Best Management Practices to store or treat stormwater runoff to reduce pollutant loads (e.g., nitrogen, phosphorus, sediments) and mitigate flooding to improve water quality in local watersheds and the Chesapeake Bay. This project is consistent with Maryland's climate change adaption and resiliency objectives through the reduction of runoff that is exacerbated by increased precipitation or flooding events.

Financing Description:

A. New Loan (up to) \$65,000,000 – Water Quality State Revolving Loan Fund

Term. Period not to exceed 30 years following project completion

Rate. Disadvantaged community interest rate of 25% of the average of the Bond Buyer 11-Bond Index for the month preceding loan closing. (Based on this formula, in fiscal year 2021 loan recipients received an interest-rate of 0.40%)

Security. To secure this debt, Borrower will deliver its bond to the Maryland Water Infrastructure Financing Administration pledging the revenue from the Watershed Protection and Restoration Fund for the payment of debt service.

Description: Engineering Services for design and construction services related to improvements to the water treatment system at Swallow Falls State Park.

Procurement: A/E Shortlist

Remarks: The preliminary design identified the need for two new back-up wells to be drilled along with an upgrade of the water treatment plant. The first new well drilled in 2021 was tested and had excellent water quality and quantity. An attempt to drill a second test well as backup was not successful. DNR determined it was not viable to develop any other well in the environmentally sensitive management area, therefore, the design has changed substantially.

Based on the available water source, the overall treatment process was re-evaluated. The A/E determined that upgrading the existing system and combining the water from both the existing well and the new well is the best option. Utilizing the current water treatment plant footprint would allow for minimal disturbance to Park activities. The current water treatment plant building is approximately 29 years old and is still in good shape, but several existing mechanical systems are old and beyond their useful service life. Proposed improvements include the replacement of the existing treatment equipment to remove the relatively high levels of iron in the raw water.

Bidding and construction phase services, which are needed at this time, were not included in the preliminary design for the water treatment plant. The scope of work associated with this contract includes the additional detailed design for the treatment process, design of the new well supply pumps and piping, associated electrical and control systems, and bidding and construction-related services.

MPS, in responding to this situation, contacted two Maryland-based janitorial vendors that had shown previous interest in the work; both provided quotes for the needed services. However, one vendor was denied tax clearance and the second vendor showed a complete misunderstanding of the work specifications. Also, due to the varied ways in which the Greenbrier requires cleaning, the second vendor could not provide cleaners all day long during the busy season; a requirement per the MPS specifications. Additionally, the second vendor was also not familiar with the preferred cleaning products and lacked familiarity with the spray foam cleaning method used for night cleaning.

Foxx's Cleaning Service was contacted as they currently have active contracts at Cunningham Falls and Elk Neck State Parks to provide janitorial services. Foxx's cleaning provided a quote of \$114,389.67 and was available to begin work immediately and has approved tax clearance.

Basis for Selection: Foxx's Cleaning Service was selected after contacting several janitorial vendors who appeared to be capable of handling the scope of work needed at Greenbrier State Park, but Foxx's Cleaning Service was the only vendor that could meet the needs of the park, understood what was required, and was ready to begin. The annual subscription fee for the Instant ID Business (Employer Fraud) is \$61,560. The additional fraud prevention is very much needed as Maryland Unemployment Insurance Division has seen a significant increase in the number of people registering fictitious employers. Maryland staff need assistance to help identify which of these accounts being registered are legitimate employers and not fictitious. If fictitious employers are not identified they attempt to report wages on the account and then file claims against these wages for benefits payments. Lexis Nexis has a system to analyze the data provided during registration and identify which of these accounts are high risk of being a fictitious employer. Staff can then use this data to determine if the account should be reviewed further or canceled before the fraud can happen.

In an effort to serve Maryland citizens effectively and quickly, the agency executed a contract modification with LexisNexis Risk Solutions under the Emergency Procurement process. Nevertheless, LABOR will issue a new RFP for Identity Verification Services in the future so as to ensure fair competition while providing Maryland citizens protection from potential fraud.

Remarks (cont'd):

SBE made an emergency procurement award on June 17, 2022. Since the contract total for printing and shipping of these applications was historically under \$50,000, SBE did not anticipate that the amount would dramatically exceed our delegation. The single bid and the higher-than-expected cost are attributed to the extreme shortage in the paper market currently.

This year's timeline for this procurement is tight. SBE annually prints Voter Registration Applications and aligns the printing with the end of each legislative session to ensure that the Voter Registration Applications includes any recently enacted legislative changes. While the application did not need to be updated as a result of the 2022 Legislative Session, changes to the oath printed on the Voter Registration Applications were proposed at the April 27, 2022, meeting of the State Board of Elections and approved at its June 2, 2022, meeting.

Basis for Selection: In 2021, SBE conducted a certification process in which three vendors were certified as capable of providing Voter Registration Applications based on paper samples provided and approved by SBE's Director of Voter Registration. The three certified vendors are: Taylor Communications, Fort Orange Press, and Runbeck Election Services.

When SBE issued the procurement request to the certified vendors, only 1 of the 3 certified vendors was able to secure the required paper stock despite their best efforts. This vendor was only able to secure paper after an extensive search exploring many paper sources not commonly used by the vendor, due to the current paper shortage.

Having ensured compliance with §10-305 (c)(2) of the State Finance & Procurement Article, albeit subsequent to the Board’s prior approval, the University respectfully requests that the Board confirm and affirm its prior approval of the acquisition of the property.

Institution Remarks: The University requests approval from the Board of Public Works to acquire (32) three-bedroom student housing units from SGV – Salisbury, LLC (the “Seller”). The units comprise the entire student housing complex known as Seagull Village located at 1401 Seagull Lane, Salisbury, Maryland (the “Property”). The units are divided between four (4) eight-unit buildings on a site which includes parking and green space. The purchase price is \$3,681,250. The University previously leased units in this facility for its international students.

The University will use these units to replace the fifteen modular housing units at Dogwood Village which are long past their useful life having been installed in 1985. Dogwood Village currently contains 140 beds and has been used for quarantine and isolation units during the pandemic. The slight loss of beds will be offset by the University’s small enrollment decline. The Dogwood Village site is a high-profile corner of the main campus which is more appropriate for a major campus building and will be evaluated during the University’s next facilities master plan. While Seagull Village will require capital investment in renovations, these units are much more viable long-term than the units at Dogwood Village and will generate more revenue on a per bed basis.

As a condition of the sale and purchase of the Property by the University, prior to the conveyance of the Property to the University, the Seller granted to the Maryland Environmental Trust a conservation easement encumbering the Property, which preserves the agricultural and environmental attributes of the Property in perpetuity. (See DNR Real Property Agenda, Item 13A, March 24, 2021.)

The Property will be used for the grazing of the Wye Angus herd that was gifted to the University System of Maryland Foundation, Inc. by Arthur A. Houghton in 1979. Requesting Agency Remarks: On March 13th, 2021, the solicitation was advertised in The Daily Record, MDOT SHA's website, and eMaryland Marketplace Advantage. Approximately 1,918 potential vendors were electronically notified by eMMA. The Department also directly solicited 563 vendors. Five proposals were received and opened on date. All awardees received a debriefing, and no protests were filed.

The contracts will directly support, among other things, Office of Transportation Mobility and Operations (OTMO's) CHART Program. Each year, the University of Maryland conducts an evaluation and benefit analysis of the CHART program. In the most recent evaluation (for Calendar Year 2020), CHART saved highway users approximately \$1.1 billion and reduced delays on the State's highways by 23.5 million vehicle-hours (which is a value calculated to determine the overall reduction in incident delays as a result of the CHART program). These benefits can be attributed to a significant degree to the interagency coordination of CHART and Maryland State Police that is facilitated through this agreement. Requesting Agency Remarks: The Maryland Department of Transportation State Highway Administration (MDOT SHA) contracts with InfoTech on behalf of MDOT TBUs to provide electronic bidding services at no cost to the State but at a monthly subscription fee to the potential bidders on state construction contracts. COMAR 21.03.05.04 requires any agency charging fees for electronic procurement transactions or a private contractor working for the State charging fees for electronic procurement transactions to seek BPW approval to charge fees. The Board approved a five-year contract with Infotech on December 21, 2016, to provide these services (DOT Item 13-GM), for a period beginning on February 21, 2017, and ending on February 21, 2022. The original agreement allowed for five additional, one-year renewals, the first of which was approved by the Department on February 18, 2022. The renewal further contained a contract modification consolidating the four one-year terms into one four-year term, to be renewed automatically. However, those renewal options were not mentioned in the original agenda item, nor was the first renewal and contract modification presented to the Board before the initial term's expiration date.

BidX requires a fee for potential bidders only. Subcontractors (MBE, DBE, SBE), suppliers and vendors who do not plan on bidding on contracts have limited access to BidX, free of charge, to search contract lettings, contract numbers, and descriptions. All projects solicited through BidX are posted on eMaryland Marketplace (eMMA). MDOT SHA has received construction bids exclusively online since July 2017, and MDOT MdTA since January 2020.

Below is a snapshot of the BidX user community:

The benefits of continued use of BidX for electronic bidding include the following:

- BidX is used in 39 states, five of which use it across multiple agencies.
- BidX is fully integrated with AASHTOWare, a suite of software modules, developed by the American Association of State Highway and Transportation Officials (AASHTO) and designed to support state construction programs. MDOT uses AASHTOWare to produce files that get uploaded to BidX to advertise the bid.

During the advertisement phase, MDOT can download plan holders into AASHTOWare. After the bid is opened, the Department downloads each bid to the line-item level and imports that data into AASHTOWare, where it forms the basis of the bid justification. Switching construction bid letting to eMMA would require entering all data manually, since eMMA does not interface with AASHTOWare

- Bid packages are validated for affirmations and identifies the missing documentation. It notifies bidders prior to submitting the bid about errors and incomplete elements, reducing mistakes. This will reduce SHA efforts to manually check for missing affirmations and missing addenda, decreasing the post bid-opening processing time.
- Small businesses have a dedicated region in which to interact online with prime contractors, providing a greater opportunity for them to be included in bids, developing more resources for MDOT contracts, increasing competition.
- The Federal Highway Administration (FHWA) has a program that allows Disadvantaged Business Enterprises (DBEs) to submit for full reimbursements for the fees they may incur in using online bidding resources.

RETROACTIVE approval is requested pursuant to § 11-204(c) State Finance & Procurement Article. MDOT TSO has determined that this contract should be treated as voidable rather than void because: (1) all parties have acted in good faith; (2) ratification for the procurement contract would not undermine the purposes of the Procurement Law; and (3) the violation, or series of violations, was insignificant or otherwise did not prevent substantial compliance with the Procurement Law. MDOT SHA is requesting that the BPW ratify the modification that did not receive necessary approvals beforehand.

Requesting Agency Remarks: The disaster recovery industry generally operates on the “roll back” protocol when allocating resources at the time of a disaster. This means that customers who declare disasters are assigned to specific recovery facilities in the order that declarations are received by the vendor and are not guaranteed a specific recovery location in advance. This is extremely risky and untenable for Comptroller’s needs because the agency data is replicated continuously to Recovery Point Systems, Inc. 's (RPS) Germantown, Maryland site. If the agency were to be assigned to another location due to multiple declarations occurring amidst a major regional disaster and other customers had declared ahead of us, the recovery would fail.

It is impossible to migrate our data to another recovery facility, no matter where it is, in time. RPS is the only vendor that will guarantee that the recovery location will not change, no matter how many declarations occur at the same time.

The disaster recovery industry generally operates on an unlimited oversubscription resource allocation model whereby, almost like an airline seat, vendors intentionally “oversell” many customers access to the same technology resources hoping that, at the time of a disaster, they will all not need service at the same time.

However, if there is a major regional event, such as a hurricane or natural disaster, and many customers in a limited geographic area do indeed need concurrent access to the same contracted resources for recovery, the vendor will be unable to perform, and many customers will fail. RPS is willing to eliminate this risk for the Comptroller by contractually committing not to over-subscribe the mainframe resources Comptroller needs in our immediate area, to include Baltimore, MD and Washington, DC.

The Comptroller's IT resilience strategy requires the ability to continuously replicate real time data to the recovery site so that if we need to restore operations there our data is very current and the time to recovery will be extremely brief. Agency's technology solutions require low latency and scalable network services for performance and highly secure bandwidth to meet the data privacy requirements. Public communications networks are not conducive to providing these types of services. RPS is the only disaster recovery vendor that also builds and manages secure, dark fiber services for customer data replication needs and has implemented a completely private dark fiber-based solution between our main data center at TierPoint and their recovery center.

Given the complexity of our colocation efforts to Tierpoint, combined with the multi-year implementation of the new integrated tax system (COMPASS), COM anticipates that following the expiration of this contract, we will continue our contractual relationship with Recovery Point under a multi-year sole source contract until the above-mentioned projects are completed and a complete assessment of our new DR requirements can be made. At that time, we will issue an RFP to competitively acquire ongoing DR services.

A price comparison of RPS prices that best matched RPS services on the GSA schedule showed COM overall price was approximately 43% lower than GSA prices. In addition, with a new three-year contract, COM has avoided a 4% annual escalation charge which is approximately \$70,000 over three years.

Requesting Agency Remarks: The Medical Cannabis Seed-to-Sale tracking system is required under current statute and is a critical tool for the Commission to ensure product quality, safety, and security. At this time, all medical cannabis licensees are required to participate in the statewide tracking system program.

The Maryland Medical Cannabis Commission (Commission), in consultation with the Department of Information Technology (DoIT), issued a Request for Proposals (RFP) for a successor Medical Cannabis Seed-to-Sale Tracking System with a submission deadline of December 4, 2021. However, in light of legislation passed by the Maryland General Assembly after the RFP submission deadline, the Commission strongly believes it is in the best interests of the State for the Board to approve a modification and two-year extension of the existing contract, rather than award a new five-year contract. The RFP was canceled in accordance with COMAR 21.06.02.02C. The cancellation was posted on eMMA.

After the Commission issued the Medical Cannabis Seed-to-Sale RFP, the Maryland General Assembly passed House Bill 1 and House Bill 837, which, subject to ratification by the voters of Maryland, will legalize the possession and use of cannabis by individuals 21 years of age and older. HB 1 and HB 837 materially impact the medical cannabis program and Medical Cannabis Seed-to-Sale Tracking System RFP in the following ways:

- **A new regulatory body.** Subject to the referendum, Section 8 of HB 837 names the Alcohol and Tobacco Commission (ATC) as the “successor of the Natalie M. LaPrade Medical Cannabis Commission in matters concerning the regulation of medical cannabis.”
- **Different IT system.** The ATC receives IT support from the Office of the Comptroller, rather than DoIT, and may need different technical requirements as compared to those outlined in the seed-to-sale RFP issued by the Commission. A seed-to-sale system procured by the Commission at this time may not be compatible with the ATC’s IT systems and therefore may not present the best value to the State over the anticipated duration of the contract.

- **Additional or different requirements.** If the Constitutional amendment proposed in HB 1 is ratified by the voters, the General Assembly will be required to adopt legislation for the regulation and taxation of cannabis, and this legislation may establish additional or different requirements for a seed-to-sale tracking system than does the current law. Likewise, the current medical cannabis statutes will likely be reconsidered and recodified, potentially leading to additional or different requirements for a medical seed-to-sale tracking system.

Given the General Assembly’s stated intent for a new agency to regulate medical and adult-use of cannabis in the State within the next year, the Commission does not believe it should issue an award for a five-year contract, especially with uncertainty surrounding the regulatory structure of a combined medical and adult-use cannabis program.

In addition, the Commission only received two bids for the Medical Cannabis Seed-to-Sale Tracking System RFP that closed in December 2021. This is despite the fact that there are several companies providing seed-to-sale software solutions across more than thirty-five states and that nine companies attended the pre-proposal bid conference. The Commission contacted each of the pre-proposal bid conference attendees that chose not to submit a bid and multiple firms shared that the ID card printing and mailing services added to the RFP, which were not included in the original RFP in 2016, dissuaded them from pursuing the contract. The Commission believes that a new RFP for a seed-to-sale tracking system only, without additional ID card printing and mailing services, may increase competition for the award, and present the best value to the State. A new RFP for a seed-to-sale tracking system, without additional ID card printing and mailing services, could be issued after the voters of Maryland and the General Assembly clarify the regulatory structure for cannabis moving forward.
