





5. <u>BOARD OF PUBLIC WORKS</u> *Wetlands License - #20-1533 – William Harris*

Recommendation: The Board of Public Works Wetlands Administrator recommends that the Board grant a tidal wetlands license for beach nourishment and the construction of a stone groin (jetty), a project involving filling in the navigable waters of Maryland.

MDE: The Maryland Department of the Environment concurs with this recommendation.

ANNE ARUNDEL COUNTY

20-1533 *WILLIAM HARRIS* – To reduce shoreline erosion by providing beach nourishment with sand and installing a stone groin.

Pasadena, Chesapeake Bay Special conditions: Requirements for beach nourishment area construction.

Application: The property of Mr. William Harris, the applicant, contains 225 linear feet of shoreline on the Chesapeake Bay, with no existing erosion control structures. Mr. Harris has applied for a tidal wetlands license to nourish his beach with sand and install a 41.66 linear foot groin on his property.

Public Comment to the Board: Ms. Elizabeth Anderson, an adjacent property owner, opposes the Board granting the proposed license. Ms. Anderson is concerned that the proposed groin may harm the beach on her property. Ms. Anderson objects to the process MDE followed in issuing its recommendation that the Board grant the license, specifically whether Mr. Harris demonstrated an erosion problem at his beach justifying the proposed groin. Ms. Anderson also called into question whether MDE's Living Shoreline Waiver process was followed, as well as MDE's change in project classification from Shore Erosion Control (COMAR 26.24.04.01.D(1)) in the first MDE Report and Recommendation to Filling/Beach Nourishment (COMAR 26.24.03.06.D) in addition to Shore Erosion Control (COMAR 26.24.04.01.D(1)) in MDE's revised Report and Recommendation.



5. <u>BOARD OF PUBLIC WORKS</u> (cont'd)

Wetlands Administrator's Review: The Board of Public Works' Wetlands Administrator visited the site, reviewed MDE's revised Report and Recommendation and comments submitted, and discussed the project with the applicant's agent, interested persons, and a coastal engineer. The proposed 41.66 linear foot stone groin is significantly shorter than three upcoast groins. The shorter groin length is expected to create less sand transport and/or disruption to sediment transport than the longer upcoast groins, especially given that sand will be added with the groin installation and offset potential interruption to sediment transport. Examination of the unique location of the Harris beach (facing east) combined with seasonal sediment transport characteristics (in summer moving northward and in winter from the northwest or northeast) support a determination that the proposed groin should not harm Ms. Anderson's property. This conclusion is supported by two engineering publications that identify acceptable lengths and distances from a property boundary that a proposed groin should follow.

A beach nourishment project with a sand containment structure, in this case a groin, is a frequently regulated tidal wetlands activity requiring a BPW license or an MDE permit/license. In 2021, BPW issued wetlands licenses for nine beach nourishment projects; eight of the nine projects (89%) include a stone structure or a timber groin as part of the beach nourishment design. The Harris final design was approved by MDE, and the Department of Natural Resources had no concerns with the project. The U.S. Army Corps of Engineers reviewed and approved the original project design (prior to revision) and issued a General Permit on April 5, 2021.

Mr. Harris is proposing a 41.66 linear foot groin in lieu of a 225 linear foot stone revetment that would utilize far more stone than the groin. The Wetlands Administrator agrees with MDE that the groin footprint is favorable ecologically compared to the larger impact of a revetment or breakwater along the entirety of Mr. Harris's 225 linear feet of shoreline. MDE and the Administrator concur that the Board of Public Works should grant this license.

Wetlands License -- #21-0154 - Town of Queenstown *Mitigation*

Recommendation: The Board of Public Works Wetlands Administrator recommends that the Board grant a tidal wetlands license to improve navigable access by reconstructing an existing public boat ramp and additionally recommends mitigation to improve habitat by eradicating 600 square feet of an invasive plant, *Phragmites*, to offset impacts to 19 square feet of vegetated tidal wetlands.

MDE: The Maryland Department of the Environment concurs with this recommendation.

Authority: The "Board shall decide if issuance of the [tidal wetlands] license is in the best interest of the State, taking into account the varying ecological, economic, developmental, recreational, and aesthetic values [the] application presents." Section 16-202, Environment Article, Annotated Code of Maryland; see also COMAR 23.02.04.

Mitigation: The replacement concrete boat ramp will result in permanent impacts to 19 square feet of vegetated tidal wetlands. MDE recommends that the Licensee eradicate 600 square feet of Phragmites as mitigation for permanent impacts to 19 square feet of vegetated tidal wetlands. Out of kind mitigation (i.e. *Phragmites* eradication for loss of vegetated tidal wetlands) is stipulated by regulation to occur at a ratio of 4:1 (COMAR 23.02.04.11.B). The 600 square feet far exceeds the required mitigation amount of 76 square feet.





Remarks: W.R. Grace and Co. operates an industrial facility located at 5500 Chemical Road in Baltimore. A silicate byproduct is produced by the industrial processes and is landfilled onsite at the W.R. Grace Industrial Landfill/Monofill. MES provides material management, landfill maintenance, grounds maintenance and landscaping, onsite pond dredging, and other services as needed. The landfill is currently in compliance with all applicable MDE permits. In 2014, MES was approached by W.R. Grace to operate the Landfill. The volume of material that is landfilled is small and does not require a full-time staff on site each day. MES was uniquely qualified to perform the work based on its successful experience operating landfills. MES is also able to commit labor resources from other nearby operations allowing for an economy of scale that reduces the cost of operations. In reviewing the request, MES determined that the work is consistent with its authority under the MES Act, leads to sound environmental stewardship, and provides an economic benefit to the State through its support of an important Maryland industry.


MES has continually operated the W.R. Grace landfill since 2014. The current MES contract (2-17-4-42) with W.R. Grace & Co. for landfill operations expires on June 30, 2022. W.R. Grace requested a proposal for a new 3-year contract term from July 1, 2022 to June 30, 2025, including the option of two 1-year extensions. The final end date of this contract will be June 30, 2027 if the renewals are exercised.


Remarks: This project is one of several deferred maintenance/site improvement projects to be covered by the MCCBL funded amount of \$10,000,000.

The contract amount has been adjusted and exceeds \$1,000,000 through a series of change orders (including this change order), that were previously authorized by Morgan State University. This work is to include the completion of the build out of three manholes that was not included in the original scope of work. In February of 2021, the Department of Budget and Management approved a scope modification to include the manholes. The majority of the changes were required after the contract was awarded as one was not able to get into the manholes while the steam was on to fully assess the problems.

This is the first of several projects to be submitted over the course of the year.







Recommendation:	The Maryland Historical Trust recommends that the Board of Public Works approve the activities of the Maryland Maritime Archaeology Program as proposed for the 2022 field season. This Item also summarizes the Program's 2021 activities.
Authority:	Sections 5A-333–5A-346, State Finance & Procurement Article, Annotated Code of Maryland

Background: The Submerged Archaeological Historic Property Act established the Maryland Maritime Archaeology Program (MMAP) within the Maryland Historical Trust. This Act charges the Trust with identifying and managing the State's submerged archaeological sites. Under the Act, anyone seeking to excavate or disturb submerged archaeological sites on State lands must obtain a permit from the Trust. The law specifically exempts the Trust from the permit requirement. Instead, the Trust must obtain Board of Public Works approval before undertaking any activity that would otherwise require a permit. In 2022, the Trust proposes to carry out a number of activities that require Board approval.

PROPOSED 2022 ACTIVITIES REQUIRING BOARD APPROVAL

The 2022 MMAP field season will include survey of known sites as well as work in new survey areas around the State. Investigations will use remote-sensing technology and visual inspection. Limited testing and excavation may be undertaken. This may entail the recovery of diagnostic artifacts to determine site age and significance. Trust staff will conserve and analyze these objects and write a report. MMAP activities are open to volunteer participation. Proposed activities are dependent on funding and on necessary health and safety considerations as the COVID-19 pandemic evolves.

Mallows Bay (Charles County)

MMAP will continue to partner with Charles County, DNR, and NOAA, as well as the Sanctuary Advisory Council on education and outreach programs as well as the management of the historic vessels and cultural resources in the Mallows Bay-Widewater Historical and Archaeological National Register District, now also the Mallows Bay-Potomac River National Marine Sanctuary. MMAP will provide guidance and oversight in planning a field school at the sanctuary previously proposed by East Carolina University for 2020, which had been postponed until 2022. This University is also seeking partnership on a variety of interdisciplinary research opportunities both related to and separate from the planned field school.

U-1105 Historic Shipwreck Preserve (St. Mary's County)

MMAP staff will undertake remote sensing survey of the submarine it co-manages with Naval History and Heritage Command and St. Mary's County Museum Division, that was postponed last year. This is part of ongoing condition monitoring but will also facilitate research being undertaken by the non-profit organization, Battle of the Atlantic Research and Expedition Group (BAREG). This organization has received an Historic Preservation Non-Capital Grant from the Maryland Historical Trust and will be collecting data that will benefit all the agencies managing this Preserve. Fieldwork is scheduled for the Spring and all health and safety practices necessary at that time will be observed.

Curtis Bay and Curtis Creek (Baltimore City and Anne Arundel County)

MMAP will undertake the recording and documentation of the historic vessels located in several loci within Curtis Bay and Curtis Creek.

Upper Potomac River (*Washington County*)

MMAP is planning to revisit known sites and undertake survey in several areas of the upper Potomac to assess the condition of previously reported Native American and Colonial fish weirs and search for and assess navigational structures related to commerce on the river that culminated in the C&O Canal. This project will take several years and include other counties over time.

Diverse field investigations (Various Counties)

MMAP will continue to conduct site inspections as needed to assist Trust staff reviewing projects in compliance with state and federal historic preservation laws. These will be undertaken only as necessary and while observing all practices necessary for health and safety.

Non-profit organizations will continue to inspect, maintain, deploy, and retrieve the mooring buoy of the U-1105 Historic Shipwreck Preserve when necessary – under the auspices of MMAP. This will be necessary for the BAREG survey referenced above. This will be undertaken only as necessary and while observing all practices necessary for health and safety.

MMAP will continue to provide lectures, courses, field activities, and other educational programming related to maritime archaeology. Staff will continue to provide hands-on experiences in site recording methods and remote sensing to volunteers, interns, and members of non-profit volunteer organizations which work in Maryland. These services will be provided virtually when possible and some will be postponed until they may be undertaken in a safe and healthy manner.

MMAP will continue to facilitate the updating of the U.S. Coast Guard and EPA Emergency Response Area Contingency Plan, MMAP reviews and evaluates shoreline and submerged archaeological historic properties to prioritize protection and response strategies. This is likely to continue to be in a virtual manner.

PROPOSED 2022 ACTIVITIES REQUIRING BOARD APPROVAL (cont'd)

MMAP will continue to participate in and provide guidance to state and federal agencies, such as the Department of Natural Resources regarding aquaculture and development in Maryland waters; the Bureau of Ocean Energy Management on issues related to offshore wind energy development; with the Department of Homeland Security's Maritime Security Committee; and the Maryland and Potomac Area Contingency Planning Committee. These activities may require limited field investigations. General meetings are likely to continue to be in a virtual manner.

SYNOPSIS OF THE 2021 FIELD SEASON

The 2021 MMAP field season was, of course, impacted by the ongoing pandemic. In an effort to ensure the safety of staff and members of the public and, in compliance with State directives, planned fieldwork was postponed. When necessary for compliance purposes or when possible while observing all safe health practices and social distancing some limited field activities were undertaken.

U-1105 Historic Shipwreck Preserve (St. Mary's County) Postponed.

Remote sensing survey of the submarine MMAP co-manages with Naval History and Heritage Command and St. Mary's County Museum Division had to be postponed due to staffing limitations and pandemic-related health concerns. This work is part of ongoing condition monitoring but will also facilitate research being undertaken by the non-profit organization, Battle of the Atlantic Research and Expedition Group (BAREG). This group has received a Historic Preservation Non-Capital Grant from the Maryland Historical Trust and will be collecting data that will benefit all the agencies managing this Preserve. It was scheduled for the late Spring/Summer.

Curtis Bay and Curtis Creek (Baltimore City and Anne Arundel County) Postponed.

MMAP will undertake the recording and documentation of the historic vessels located in several loci within Curtis Bay and Curtis Creek.

Mallows Bay (Charles County)

At the Mallows Bay-Potomac River National Marine Sanctuary MMAP continued to manage the WWI fleet of wooden steamships present there as well as other cultural heritage resources and worked with partner agencies to implement the sanctuary management plan as well as educational and outreach projects.

Other Educational Programming (Various Counties)

In 2021 staff provided and organized various virtual lectures on maritime archaeology, and virtual trainings for students, volunteers, interns, and members of non-profit volunteer organizations, which work in Maryland.


Diverse field investigations (Various Counties)

MMAP continued to conduct site inspections as needed to assist Trust staff reviewing projects in compliance with state and federal historic preservation laws, while observing all necessary health safety practices and social distancing.

The non-profit organization, IMH, suspended activities to inspect, maintain, deploy, and retrieve the mooring buoy when necessary – under the auspices of MMAP. The mooring buoy was not deployed as staff and volunteers could not do this in a sufficiently distanced manner. The USCG was aware that the buoy was off-station until BAREG replaced and recovered it for its specific project safety requirements.

MMAP continued to facilitate, virtually, the updating of the U.S. Coast Guard and EPA Emergency Response Area Contingency Plan, MMAP reviews and evaluates shoreline and submerged archaeological historic properties to prioritize protection and response strategies.

MMAP continued to participate in and provide guidance to state and federal agencies, such as the Department of Natural Resources regarding aquaculture and development in Maryland waters; the Bureau of Ocean Energy Management on issues related to offshore wind energy development; with the Department of Homeland Security's Maritime Security Committee; and the Maryland and Potomac Area Contingency Planning Committee. Meetings were conducted via tele-or video-conferencing due to the pandemic.

MSA and the CM conducted pre-bid and site visit meetings at the project site, and all attendees were provided with summary project information and afforded the opportunity to tour the project site. Additionally, outreach and networking sessions were conducted virtually on October 12, 2021, December 9, 2021, January 5, 2022, and February 11, 2022. The sessions were attended by numerous trade contractors and other representatives regarding contracting opportunities and MBE participation.

On February 8, 2022, competitive sealed trade contractor bids were received and opened using the CM's online bidding system, BuildingConnected. The CM received 37 bids for the bid packages advertised. Post-bid scope review meetings were conducted virtually from February 14, 2022 to February 25, 2022. All bid openings and scope reviews were attended by MSA.

The work included in GMP Package #1 is within the current project budget.


The overall MBE participation goal for the project was set at 30% with sub-goals of 8% African American-owned and 11% Women-owned. GMP Package #1 achieves 31.69% total MBE with 2.35% African American and 4.65% Women Owned participation. The CM remains committed to meeting the MBE participation goals established for the project.

GMP Package #2 is anticipated to be submitted for approval in June 2022. This package is estimated to total between \$72 million and \$75 million excluding owner contingency.

Description: In 1967, the Washington Metropolitan Area Transit Authority (WMATA) was established through a tri-state compact between the State of Maryland, the Commonwealth of Virginia, and the District of Columbia to plan, develop, finance, operate, and maintain a rail and bus transit system for the Washington metropolitan area. The WMATA is funded by operating revenues and grants from Maryland, Virginia, D.C., and the federal government. Each year the WMATA Board approves an annual budget and a six-year capital program. The amount of Maryland's required share of funding is established through the WMATA compact, various funding agreements, WMATA's annual approved operating and capital budgets, and Maryland law. The Maryland Department of Transportation administers Maryland's funding agreements with WMATA, and Maryland's share of funding for WMATA comes from the Transportation Trust Fund.

In 2018, the Maryland Metro/Transit Funding Act (Chapters 351 and 352) passed and provides an additional dedicated capital funding grant of \$167 million per year for WMATA. Since the passage of that bill, the State's General Fund has participated in the annual funding requirements to WMATA to offset the impact on the Transportation Trust Fund of this additional funding requirement. Maryland's FY 2022 budget included the use of general obligation bond proceeds, instead of General Funds, to pay a portion of Maryland's funding requirement to WMATA. Maryland's share of FY 2022 funding for WMATA totals \$779.5 million, including \$654.5 million from the Transportation Trust Fund and \$125 million from this authorization of general obligation proceeds allocated in the MCCBL 2021.



The contractor has demonstrated competency in performing the scope of work during the last six campaigns and has worked with the Office of the Secretary of State to hone the requirements of the campaign, including branding the MCC to the State.

The Secretary of State is authorized to conduct the MCC and select an operating agency pursuant to Executive Order 01.01.1996.07. The MCC is an annual workplace giving campaign that allows Maryland State employees and retirees the opportunity to easily support hundreds of participating charitable organizations through payroll deduction. Employees eligible to participate include Regular, Contractual, and University employees. New retirees and retirees who participated in the previous three campaigns also receive campaign marketing materials and are eligible to participate. There are approximately 108,000 employees and approximately 1,300 retirees who are eligible to participate or participate each year.

The contractor has made a good faith effort to utilize its MBE subcontractors as identified in the contract; however, over the past two years, due to the pandemic, the Maryland Charity Campaign kickoffs were held virtually rather than in-person. The largest portion of the MBE participation goal is for catering services for the box lunches at the in-person kick-off meetings. During this final renewal option period, the contractor will continue to work with its MBE subcontractors or seek other MBE opportunities to meet the participation goal through the end of the contract.




Requesting Agency Remarks: The Department utilizes Residential Child Care Services (RCC) Programs for those children whose needs cannot be met in a family based foster care setting. The RCC services in Maryland are provided through five Program categories: Developmentally disabled Programs; Diagnostic Evaluation and Treatment Programs, Group Homes, High Intensity Group Home, and Medically Fragile.

The facilities are located throughout the State and serve foster care children under the care of the Department. It is in the best interest of the children and the State not to disrupt the current placement or change the existing provider for these youth.

The services of each contractor will be used at the sole discretion of DHS. DHS makes no guarantee as to the number of children/youths to be placed with any contractor. These are purchase of care contracts paid on a fee for service basis for the actual children/youth placed in a contractor's care, and then only for the actual number of days each child is with the contractor.

The proposed price for these contracts is fair and reasonable because the prices are set by Maryland State Department of Education (MSDE), Interagency Rates Committee (IRC), using the same established methodology in price setting for all In-State providers.

Residential Child Care programs are defined in COMAR 14.31.02.03B(13) as "a program of care provided in a residential setting by a provider on a 24-hour basis for longer than 24 hours to a child or children unless otherwise provided by State law." COMAR 14.31.06.01 articulates the standards that must be met and maintained by Residential Child Care programs for children and youth. These requirements are designed to protect the health, safety, and well-being of children placed in Residential Child Care programs. According to the State Finance and Procurement Article §13-107 and COMAR 21.05.05.02A (Sole Source Contracts); in order to provide continuity of human or social services care to current clients, the procurement officer shall, before the contract with the current provider expires, attempt to negotiate a sole source contract with the current provider.

Agency Remarks (cont'd):

Based on an assessment by a licensed or certified health practitioner, the head of a funding unit determines that a change in the human or social services provider would have a detrimental impact on those clients currently being served by the provider. The licensed or certified health practitioner shall be a psychologist, social worker, physician, nurse, or qualified developmental disabilities professional, as defined in COMAR 10.22.02.11A.

Of these 31 RCC Service providers, the following three providers are not included in this specific modification for the following reasons:

- 1. The Children's Guild (SSA/RCCSS-21-015) final option is not being renewed due to its program closure effective December 15, 2021.
- 2. Cedar Ridge Children's Home and School, Inc.'s, (SSA/RCCSS-21-012-A1) modification was approved on the December 1, 2021 agenda, DGS Item 37-S-OPT/MOD. The modification added funding for an additional five Therapeutic Group Home beds, four new Group Home Small beds, exercised the final one-year option renewal, and added funds due to FY 22 Interagency Rates Committee (IRC) rate adjustments.
- 3. Center for Social Change, Inc. (SSA/RCCSS-21-030-A1) modification was approved on the January 26, 2022 agenda, DGS 29-S-MOD/OPT. The modification added five Medically Fragile beds with associated funding and exercised the final one-year option renewal and added funds due to FY 22 IRC rate adjustments.

There is a 5% MBE requirement for any RCC contracted provider with 25 or more contracted beds. Of the 31 contracted providers, six have a 5% MBE compliance. Each provider's MBE compliance attainment is indicated in Attachment 1 as of November 2021.

Requesting Agency Remarks: The new solicitation is currently under final review and will be submitted to the Office of State Procurement for review and approval before publishing.

Six contracted vendors currently provide specialized psychotherapeutic services to sexual offenders throughout the State of Maryland. The five other contracts are also being extended but have remaining funds sufficient for the extension period due to less usage than anticipated. This contract has insufficient funds for an extension due to an increased number of referrals to this provider. Actual usage has exceeded original estimates because other sexual abuse treatment program closings and court closings during the pandemic caused a spike in referrals to this provider.


Specialized sexual offender treatment services were implemented in response to legislation mandating the use of sexual offender management teams known as Collaborative Offender Management Enforced Treatment (COMET) teams for the supervision of sexual offenders. *See* Md. Code Ann., Crim. Proc. § 11-725. Courts impose participation in specialized sexual offender treatment as a special condition of supervision in appropriate cases.

Specialized sexual offender assessment and treatment are essential elements of the containment approach to sexual offender management and enable parole and probation agents to develop and implement more appropriate supervision plans and strategies. If the services are discontinued, the Department would lose a vital tool in enhancing public safety by preventing future sexual offenses by parolees and probationers.


One prospective awardee submitted a protest on February 14, 2022. On February 24, 2022, the Procurement Officer issued a final decision denying the protest on the merits. The decision was not appealed.

The detection system provides security against drones and UAV systems that may approach and enter DPSCS facility properties.

911 Security's proposal included multiple features that provide unique benefit to the State or outperformed other proposals during site demonstrations. They include use of a wired network, which provides reliability over other systems, such as those that rely on cellular notifications. It also includes the non-reliance on a library to recognize drones, which enables broad detection capabilities and the ability to quickly recognize the pilot of a drone as soon as the remote is turned on. It offers the ability to "Geofence" certain areas, which minimizes or eliminates false alarms arising from the close proximity some facilities have with residential areas. Their system can provide the make/model/serial number and possible payload capacity of a drone. It has the demonstrated ability to detect more drones at one time than other offerors and prioritize threats as warnings or alerts. Additionally, it can identify common takeoff locations and repeat offenders. Their proposal offers a guaranteed one-hour technical support callback response; software updates at no additional cost; the ability to permit multiple users on the system without administrative access. Also training for multiple users and no use of subcontractors, which expedites the problem resolution process.







Requesting Agency Remarks: Labor is satisfied with the contractor's performance, and it is important to exercise the renewal option to continue the security services and launch its kiosk system in the various locations in response to the COVID-19 Pandemic.

The continuous need for a safe and secure environment for the Department of Labor employees, visitors, and customers are of paramount importance and cannot be overemphasized. Each location will require one uniformed unarmed security guard, for a period of six months, Monday through Friday except for Federal/State Holidays, and dates of the emergency closure of State Offices.
