6. **BOARD OF PUBLIC WORKS**  
***Wetlands License -- #22-1351 – John S. Larkin***  
***Mitigation***

**Recommendation:** The Board of Public Works Wetlands Administrator recommends that the Board:

1. Grant a tidal wetlands license to mechanically dredge an area, and
2. Require mitigation in the amount of \$2,408 for impacts to shallow water habitat resulting from mechanical dredging.

**MDE:** The Maryland Department of the Environment concurs with the recommendations.

- Application received December 30, 2022
- Public comment period ended June 1, 2023
- MDE Report and Recommendation June 30, 2023

**Authority:** Section 16-202, Environment Article, Annotated Code of Maryland: “*The Board shall decide if issuance of the [tidal wetlands] license is in the best interest of the State, taking into account the varying ecological, economic, developmental, recreational, and aesthetic values [the] application presents.*” See also COMAR 23.02.04.

**Mitigation:** Mechanically dredging an area will result in permanent impacts to 1,400 square feet of shallow water habitat. MDE recommends that the licensee mitigate for the 1,400 square feet of impact to shallow water habitat at a 1:1 ratio (COMAR 23.02.04.11.B) by paying \$2,408 into the MDE Tidal Wetlands Compensation Fund.

1,400 square feet x \$1.72 per square foot\* = \$2,408.00

\*Based on \$75,000/acre mitigation cost

**ANNE ARUNDEL COUNTY**

22-1351 *JOHN S. LARKIN* – To improve navigable access by removing mooring piles and a pier, constructing a platform and pier, installing boat lifts with associated pilings, mechanically dredging an area, transporting dredged material to a disposal site, and providing for periodic maintenance dredging for six years.

***Rocky Gap Casino/Resort***

***Recommendation:*** That the Board of Public Works approve:

- (1) The First Amendment to Amended and Restated Ground Lease by and between the State of Maryland, to the use of the Department of Natural Resources, and Rocky Gap Propco, LLC (a subsidiary of VICI Properties, Inc.);
- (2) The Assignment and Assumption of Ground Lease from Evitts Resort, LLC to Rocky Gap Propco, LLC; and
- (3) The Sublease of the Amended and Restated Ground Lease from Rocky Gap Propco, LLC to Evitts Resort, LLC, as amended.

***Background:*** The Department of Natural Resources (DNR) currently leases 260 acres +/- via a ground lease to Evitts Resort, LLC (Evitts). In 2012, Evitts took over as DNR's tenant from the Maryland Economic Development Corporation (MEDCO) pursuant to an assignment of an amended and restated existing ground lease between DNR and MEDCO. MEDCO was the original developer of the Rocky Gap hotel and golf course and was replaced by Evitts when the casino was added to the property, and Evitts was awarded the video lottery operation license for the Rocky Gap location.

The current owner/operator structure is one in which Evitts is DNR's tenant and operates both the resort and the casino. There is a sale pending that will result in the leasehold tenant and the resort/casino operator being two different entities. VICI Properties, Inc. (VICI) will acquire the leasehold interest from Evitts' parent company, Golden Entertainment, Inc. (Golden) via an assignment to and assumption by VICI of the Amended and Restated Ground Lease. VICI is a real estate investment trust (REIT) and will be DNR's tenant, with Evitts continuing to be the operator of the resort and casino. The existing Amended and Restated Ground Lease will be amended to reflect the new ownership and operational structure. Century Maryland Acquisition Inc., a direct and wholly owned subsidiary of Century Casinos, Inc., will acquire Evitts from Golden, and Evitts will continue to be the operator of the resort and casino as a subsidiary of Century pursuant to the Sublease from VICI to Evitts.

The Maryland State Lottery and Gaming Control Commission, at their April 27, 2023 meeting, found that Century Maryland Acquisition, Inc. meets the qualification requirements for a video lottery operation license, and that a license transfer - per the pending sale and agreement - is consistent with the policies and intent of the Gaming Law. The Commission voted unanimously to approve the addition of Century Maryland Acquisition, Inc. to the Video Lottery Operation License along with Evitts Resort, LLC. The license will be issued upon completion of the sale and the Board of Public Works approval of these items.

**Recommendation:** That the Board of Public Works approve annual funding as described

**Authority:** Maryland Water Infrastructure Financing Administration Act  
§§ 9-1601--9-1622, Environment Article, Annotated Code of Maryland.

**Project:** Operation and Maintenance Grants for Wastewater Treatment Plants

**Recipients:** Owners of the Wastewater Treatment Plants identified below

**Amount:** Up to **\$10,999,998**

**Location:** Statewide

**Project Description:** Under the Bay Restoration Fund Act, up to 10% of the annual revenue generated from wastewater treatment plant users deposited with MDE may be allocated for operation and maintenance costs of a wastewater treatment plant operating at the enhanced nutrient removal level. MDE’s grant recommendations are based on base-grant of \$30,000 for every million gallons per day of design capacity, with a minimum grant award of \$30,000 (unless prorated for partial year of operations), and maximum award of \$300,000 per year for any plant. In addition to the base-grants, additional grants are being recommended for plants achieving better than the enhanced nutrient removal level.

These plants have successfully achieved the goals of effluent levels at or below Total Nitrogen of 3 mg/l and Total Phosphorous of 0.3 mg/l, reducing nitrogen discharged to Chesapeake Bay by over 8,851,000 pounds per year, and phosphorus by over 976,000 pounds per year.

**Project:** Connect Triumph Industrial Park to County Sanitary Sewer

**Recipient:** Cecil County

**Amount:** Up to \$3,550,101

**Location:** Cecil County/Legislative District 36

**Project Description:** This project entails the decommissioning of the Triumph Industrial Park wastewater treatment plant (WWTP) and conveyance of wastewater to the Northeast River Advanced Wastewater Treatment Plant (NRWWTP), an Enhanced Nutrient Removal (ENR) facility. The work includes construction of new pump station and force main, removal of the WWTP lagoon system, and associated appurtenances. In addition to helping the County meet its obligation under the Maryland Watershed Implementation Plan, connecting to NRWWTP will address the WWTP's aging condition and NPDES permit violations, eliminate discharge to Little Elk Creek, and protect public health. This project will be constructed in accordance with coastal and non-coastal resiliency guidelines developed as part of the Coast Smart Program to reduce climate change risks to such projects.

**Project Funding Sources:**

The residential programs include treatment foster care, group homes, therapeutic group homes, shelter homes, residential treatment centers, residential educational programs or schools, and independent living programs. Home based supervision treatment and therapy are also provided.

*Basis for Selection:* Due to the unique and emergent needs of the youth, DJS reached out to other treatment programs for the placement but only Charity Hearts Healthcare, Incorporated responded positively. After assessing the situation, AET Electric, Inc. indicated that the transformer could not be repaired in place and would have to be removed. The vendor found a transformer in Ohio, which would take one week to deliver. It was determined that replacing the transformer was the best course of action due to the inefficiency of repairing the transformer. The transformer was replaced and when it was powered on, a 25KW switch blew, due to the age of the switch. The switch failure was unexpected, and the switch was needed to operate the transformer. The Holly Center attempted to locate a new switch through local high voltage companies: Choptank Electric or Delmarva Power. AET Electric was able to locate the switch in Pennsylvania. MDH made the determination to use the same vendor to source the switch as the switch failure stemmed from the original transformer incident.

*Basis for Selection:* AET Electric Inc. was the only vendor that responded immediately during the power outage at the Holly Center which was experienced on May 14, 2023. Due to the impact on a resident care building, a competitive solicitation was not made as there was an immediate need to replace the transformer.

*Reason for Late Report:* During the installation of the new transformer, the switch malfunctioned requiring additional work for functionality. As both the transformer and switch stemmed from the same incident, MDH made the determination to combine both items as one emergency. This combination caused a delay in the emergency report.

Non-participating vendors were contacted, and reasons for not participating included:

- the scope of work is beyond their capacity, and
- a conflict of interest per Code of Federal Regulations, (CFR) - 49 CFR § 674.41.

Federal legislation requires each state to have and implement a State Safety Oversight program for its rail transit systems. MDOT is the overseeing agency for the Rail Transit Safety and Security Oversight Program (SSOPS). MDOT's SSOPS describes the program and defines the respective roles and responsibilities of MDOT, transit agencies and the Federal Transit Administration (FTA) in its implementation.

Therefore, MDOT is required to perform several distinct functions. Under the direction of staff from MDOT's Office of Homeland Security, Emergency Management & Rail Safety (HSEMRS), the Consultant will be responsible for State's safety and security oversight activities. The following activities constitute the core of the FTA's State Safety Oversight Program, but are not limited to: Program Standards (Development and Implementation), System Safety Program Plan, System Security Program Plan, Internal Safety and Security Audit Program, Hazard Management Process, Accident Notification and Investigations, Three Year Review, Corrective Action Process, SSOA Reporting Requirements, Moving Ahead for progress in the 21st Century Act (MAP 21, Periodic Submissions and Special FTA Assignments, and FTA Safety and Security Operational Readiness Review (SSRR).

The Financial Proposals consisted of hourly rates for Labor Categories that are needed for individual work orders. These prices are the maximum rates that will be used in the Contractor's work orders, in which a schedule of deliverables and budget will be established for each work order issued on this contract. Based on historical contract pricing, the financial proposal was deemed fair and reasonable.

No DBE nor VSBE participation goal was established for this contract as this is a single element of work, and vendors could not be identified with the required level of expertise. Also, a VSBE goal could not be applied to this solicitation State programs cannot be applied to federally funded contracts.

This contract includes a provision authorizing an extension for a total period no longer than one-third of the base term to spend funds remaining on the contract as provided in Board Advisory 1995-1.

The Maryland Department of Transportation (MDOT) and the Maryland Transit Administration (MTA) entered into a Public-Private Partnership Agreement (P3 Agreement) for the Purple Line with Purple Line Transit Partners LLC (Concessionaire) in 2016. The Concessionaire is responsible for design, construction, financing, operations, and maintenance of the Purple Line over the term of the P3 Agreement.

**Modification Description:** Increase the P3 Agreement contract amount, extend the contract term, and modify a definition in the P3 Agreement to provide contractual relief to the Concessionaire for project delays.

**Requesting Agency Remarks:** On April 6, 2016, the Board of Public Works voted unanimously to approve a 36-year, performance-based Public-Private Partnership Agreement with Purple Line Transit Partners to design, build, finance, operate, and maintain the Purple Line Transit Project. On August 3, 2016, the Project's Record of Decision was vacated as a result of a lawsuit filed against the Federal Transit Administration. The Record of Decision was later reinstated through the appeals process but resulted in project delays. After more than two years of inability to reach agreement on the amount of time and compensation for the delay, the design-build contract held by the Concessionaire was terminated and MTA assumed control of over 150 contracts and purchase orders and continued work on the project while MTA and Concessionaire continued settlement discussions.

The BPW approved a Settlement Agreement between MTA and the Concessionaire (Modification No. 2) on December 16, 2020 to settle all claims and terminate litigation related to the Purple Line. Pursuant to the Settlement Agreement, the Concessionaire remained on the project, a process and timeline was established to procure a replacement design-build contractor and to obtain new financing for the remaining cost to complete the Project, and settlement payments were paid to the Concessionaire. Three modifications were made to the Settlement Agreement (Modification Nos. 3, 4, and 5) to provide additional time to select a replacement design-build contractor.

In accordance with the Settlement Agreement, the BPW approved the selection of Maryland Transit Solutions, a joint venture of Dragados USA, Inc. and OHLA USA, Inc., as the replacement design-build contractor and approved an increase to the contract amount, an extension of the contract term, and revisions to language contained in the P3 Agreement as Modification No. 6 on January 26, 2022. Financial close occurred in April 2022 and the Concessionaire resumed construction activities.

Modification No. 6 included MTA's responsibility to complete a certain scope of work that MTA began after the original design-build contract was terminated and provided for Concessionaire's entitlement to assert a relief event if the completion of that work is delayed. Modification No. 6 also provided for the time and compensation that Concessionaire may be eligible for if such relief event were to occur. Completion of utility relocation work performed by MTA is delayed.

Construction progress is also impacted by a number of other factors, including the complexity of onboarding a new design-build contractor to finish another contractor's work; the impact of unknown conditions at construction sites that were dormant for two years and as-built conditions that are not as expected; the impact of completing major new construction in a dense, urban environment while maintaining pedestrian and vehicular traffic; and continued impacts of nationwide workforce challenges, supply chain delays, and high inflation.

Modification No. 7 provides Concessionaire with interim relief for delayed work that includes completion of utility work being completed by MTA (a contractual relief event) and concurrent project delays by Concessionaire. Relief granted includes an extension of 207 days to the Revenue Service Availability Deadline (extending the date from Fall 2026 to Spring 2027), a net compensation payment of \$148,326,560 to Concessionaire, and a modification of the P3 Agreement to update a contractually defined term to reflect the delay. Net compensation includes an increase in payments prior to Revenue Service Availability Deadline offset by reductions to Availability Payments. Modification No. 7 also provides for a Contingent Payment of not more than \$37,660,001 if certain conditions are met.

Work along the entire 16-mile project alignment continues to advance. The project is more than 50% complete and construction is actively advancing along the entire alignment from New Carrollton to Bethesda at 60 active construction sites with approximately 700 workers. A significant amount of construction activity currently underway, including utility relocation work and replacement and upgrading of storm drain systems, has less of an impact visually than building a station but is inherently critical to the completion of the overall project.

More recognizable activities underway include several Purple Line stations currently under construction, including Bethesda, Connecticut Ave, Lyttonsville, Manchester Place, Silver Spring, Silver Spring Library, Campus Drive UMD, Riverdale Park – North, and Glenridge; bridge and retaining wall construction, including completion of Talbot Avenue in Silver Spring; light rail track being laid at several locations, including Ellin Road, the Plymouth Tunnel, and Campus Drive at the University of Maryland; and vertical excavation (blasting) of a 130-foot shaft at the Bethesda station that will connect future Purple Line riders to the Washington Metropolitan Area Transit Authority Metro's Red Line. Additionally, work continues to prepare the Glenridge Operations and Maintenance Facility to start receiving light rail vehicles in early 2024.

**Requesting Agency Remarks:** These two contracts provide for the design, production, delivery, and technical support of 40-foot (Contract A) and 60-foot (Contract B) transit buses to be delivered to the MDOT MTA over a 5-year period.

**Part A:** The total quantity of buses procured under these contracts could not, and did not, exceed \$211,771,542, the amount of capital funding that had been allocated for this procurement and approved by the Board of Public Works at the June 20, 2018 BPW meeting. However, each contract also established a not-to-exceed (NTE) amount (with yearly economic adjustments applied after the first year) that limited how much MTA could pay the contractor in a single year and those NTEs were \$22,293,953 for Contract A and \$25,541,445 for Contract B. MTA exceeded the NTE on three separate occasions.

- Year 3 – Contract B - \$32,900,226.85 paid to the vendor
- Year 4 – Contract A - \$40,605,417.16 paid to the vendor
- Year 5 – Contract A - \$40,853,016.81 paid to the vendor

**RETROACTIVE** approval is being requested pursuant to State Finance & Procurement Article §11-204(c). These contracts should be treated as voidable, rather than void, because: 1) all parties have acted in good faith; 2) ratification of the procurement contracts would not undermine the purposes of the procurement law; and 3) the violation, or series of violations, was insignificant or otherwise did not prevent substantial compliance with the procurement law.

**Part B:**

This modification to Contract A provides \$24,821,971.62 in additional contract authority to address the need to purchase buses during the Renewal Option # 1. MTA intends to order 70 buses for delivery during the Renewal Option term.

Additional funding is required due to unprecedented Producers Price Index (PPI) escalations. Much of the price increase is attributed to the increase in the cost of steel and raw materials for the bus bodies. With this modification, MTA is seeking approval to grant the contractor their requested price adjustments. The contract allows for the vendor to request, and MTA to approve, a pricing adjustment of no more than 5% based on PPI category WPU1413 “Truck and Bus Bodies.”

For Renewal Option #1, the per bus cost increases to \$726,720 (an 11.1% increase over Base Year #5) and for Renewal Option #2 the per bus price will increase to \$799,392 (a 10% increase). Noting the price adjustments are larger than the previously agreed to 5% consideration, MTA is seeking approval to grant the contractor the requested values.

If this modification is denied, MTA risks losing its place in the Nova Bus production assembly line. Since Nova Bus is closing its U.S. manufacturing facility in Quarter 1 of 2025, MTA cannot risk any additional delays. MTA must submit its orders by the end of July to avoid losing its place in the bus production assembly line and to meet the bus requirements outlined in the FTA-approved bus fleet plan. Therefore, MTA has determined that it is in the best interest of the State to grant the requested modifications. A new solicitation for Battery-Electric Transit Buses is being completed for the next cohort of buses and will be presented to the Board of Public Works for approval in the Fall.

Contract B does not require a contract modification because MTA has received all of the 60-foot articulated transit buses that it needs and has no intention of using this contract to purchase any more buses.

For transit vehicles, the DBE goals are managed through the FTA's Transit Vehicle Manufacturer (TVM) Program. Only eligible TVMs may bid on FTA-assisted transit vehicle procurements. MTA does not set, nor review the DBE participation goals.

***Requesting Agency Remarks:*** The residential boarding education program operates on a 25-acre site in southwest Baltimore City and serves 400 students from eleven Maryland counties and Baltimore City.

The previous MBE goal was set at 2.5% and The SEED School exceeded it in 2018 at 4.7%. The SEED School fulfilled their obligation to one subcontractor, another subcontractor went out of business in 2021 and the third subcontractor under the contract was unable to be reached by either email or telephone to verify performance but possibly closed their office according to State Department of Taxation records. Non-compliance with paperwork was identified and resolved. New subcontractors were identified to fulfill the continued 2.5% goal for the next option period.

The SEED School serves 400 students from 11 Maryland counties and Baltimore City. A change in vendor would disrupt the education of students in grades 6 through 12. If there was a change in vendor that did not include uninterrupted use of the current campus, the students would return to their home counties. The campus is a 25-acre site in southwest Baltimore City. The property is leased, and the facilities were renovated with private funds. There is no guarantee that the MSDE could assume the operational costs of the property, in addition to program costs.

In addition to establishing the school program, MSDE required that the operator develop and equip an appropriate campus. The SEED Foundation and The SEED School completed a capital campaign by raising over \$27 million privately and securing \$25 million in bonds to renovate the former Southwestern High School in Baltimore City and to construct two dormitories. The campus was developed with private funds to serve a public purpose. The provision of the original contract that ensures extension of the contract, as long as the program is meeting its contractual obligations, is a key component of the financing.

The contractor is exceeding all obligations with enrollment between 397 to 404 students maintained each year. In addition, the school participates in the Maryland Comprehensive Assessment Program (MCAP). The school utilizes several interim measures to track student progress and growth using nationally normed assessments in academics and youth development. A Student Support Team works with families on identification of students with special needs and with implementation of Individualized Education Programs (IEPs).

Funding for The SEED School of Maryland is determined by statute, Annotated Code of Maryland Education Article §8-709-710. The SEED School of Maryland is funded by the State paying up to \$10 million plus annual inflationary adjustment beginning in 2014 for up to 400 students in grades 6 through 12 enrolled in the program each fiscal year. In addition, the county Boards of Education will contribute 85% of the state and local cost for each student who participates in the program and domiciled in the county.

The statutory purposes of the Service Year Option program are to:

- Provide service placements to eligible young adults as an additional option to immediately pursue post-secondary education or career and technical training;
- Equip program participants with professional development, mentoring, job training and financial literacy skills, and other supports;
- Assist in addressing the State's most significant challenges by channeling the next generation into impactful public service;
- Strengthen the talent pipeline into state and local governments to fill present and future staffing needs and;
- Enroll at least 200 participants in FY 2024.

In this regard, it is the determination that BuildWithin Inc. is the only supplier that is currently in the Market that can provide the services to fully meet the statutory requirements.
