**5. BOARD OF PUBLIC WORKS**

***Procurement Directive; COMAR: State Procurement Regulations***

***Background:*** The Board of Public Works declined a petition for declaratory ruling at its November 16, 2022 meeting (Secretary's Agenda, Item 25) and directed the Board's Procurement Advisor to conduct an investigation of the allegations and complaints set forth in the petition and to submit a report to the Board with the investigation's findings and recommendations. The Procurement Advisor's investigation report contained Recommendations 1 and 2 (below) based on the findings in the report.

***Authority:*** Sections 12-101, 14-302, and 14-303, State Finance and Procurement Article, Annotated Code of Maryland.

***Recommendation 1:*** That the Board of Public Works direct the Department of General Services to initiate and conduct a new procurement for Statewide Fuel Supply and Maintenance Services, with the new procurement solicitation published no later than 90 days after the Board's approval of this recommendation. The Department of General Services shall provide to the Board updates as to the status of the new procurement at least once per calendar month until a new contract award recommendation from that procurement is presented to the Board.

***Recommendation 2:*** That the Board of Public Works propose amendments to COMAR Title 21, State Procurement Regulations, to revise the Minority Business Enterprise (MBE) Policies to make it explicitly clear that:

- State-recommended-awardee subcontract agreements with MBEs need to be established prior to any state contract award with MBE subcontractor participation;
- Those MBE subcontract agreements need to include all necessary terms, including pricing, required for MBEs to perform their proposed work and for the state-recommended-awardee to pay the MBEs for their work during the contract term; and
- State procuring agencies must review those MBE subcontract agreements and confirm that the MBE subcontract agreements include all necessary terms prior to any state contract award with MBE subcontractor participation.

**MDE:** The Maryland Department of the Environment concurs with this recommendation.

**ANNE ARUNDEL COUNTY**

22-0636 *LINDAMOOD IMPROVEMENT ASSOCIATION* – To improve navigable access and reduce shoreline erosion by mechanically maintenance dredging areas, transporting dredged material to a disposal site, replacing in-kind a timber bulkhead, and providing for periodic maintenance dredging for six years.

*Annapolis, Cove of Cork*

*Special conditions: Time of year restrictions. ***Wetlands License - #22-0444 – Baltimore Gas and Electric Company (BGE)***

**Recommendation:** The Board of Public Works Wetlands Administrator recommends the Board:

- (1) Grant a wetlands license for a project involving the installation of fourteen cables crossing 589.4 linear feet of State Tidal Wetlands; and
- (2) Assess annual compensation of \$20,629 to be deposited into the MDE Wetlands and Waterways Program Fund.

**MDE:** The Department of the Environment concurs with this recommendation.

- Comment period closed February 1, 2023
- MDE Report and Recommendation received April 4, 2023

**Authority:** Section 16-202, Environment Article, Annotated Code of Maryland. “*The Board shall decide if issuance of the [tidal wetlands] license is in the best interest of the State, taking into account the varying ecological, economic, developmental, recreational, and aesthetic values [the] application presents.*” See also COMAR 23.02.04.01.C. and COMAR 23.02.04.12.E.

**Compensation:** This license contains a recommendation that the Board assess compensation. The licensee seeks to install eight electric triplex cables, one fiber optic cable, and five spaces available for additional fiber optic cables (totaling 14 cables) over 589.4 linear feet of State Tidal Wetlands. The Wetlands Administrator recommends annual compensation of \$20,629 calculated as follows:

589.4 linear feet (14 cable lines) x \$2.50 per linear foot\* of tidal wetland impact = \$20,629.00

163 linear feet (2 cable lines) x \$2.50 per linear foot\* of tidal wetland impact = \$815.00

***Wetlands License -- #22-1192 – Brian Kmet***  
***Mitigation***

**Recommendation:** The Board of Public Works Wetlands Administrator recommends that the Board:

1. Grant a tidal wetlands license to nourish a 90-foot long by 22-feet wide beach with approximately 72 cubic yards of sand fill, and
2. Require mitigation in the amount of \$4,386.00 for impact to submerged aquatic vegetation (SAV) resulting from the sand fill.

**MDE:** The Maryland Department of the Environment concurs with the recommendations.

- Application received November 9, 2022
- Public comment period ended April 1, 2023
- MDE Report and Recommendation April 12, 2023

**Authority:** Section 16-202, Environment Article, Annotated Code of Maryland: “*The Board shall decide if issuance of the [tidal wetlands] license is in the best interest of the State, taking into account the varying ecological, economic, developmental, recreational, and aesthetic values [the] application presents.*” See also COMAR 23.02.04.

**Mitigation:** Nourishing a 90-foot long by 22-feet wide beach with approximately 72 cubic yards of sand fill will result in new impacts to 850 square feet of SAV. MDE recommends that the licensee mitigate for the 850 square feet of impact to SAV at a 3:1 ratio (COMAR 23.02.04.11.B) by paying \$4,386.00 into the MDE Tidal Wetlands Compensation Fund.

850 square feet x 3 (3:1 ratio) x \$1.72 per square foot\* = \$4,386.00

\*Based on \$75,000/acre mitigation cost.

**Recommendation:** The Board of Public Works Wetlands Administrator recommends the Board approve a modification to Tidal Wetlands License No. 20-0957 which authorized mechanical dredging and a six-year maintenance dredging period. The modification includes adding an option for hydraulic dredging and providing beach nourishment to an adjacent beach.

20-0957(R) *COVE CREEK CLUB HOA – To improve navigable access by mechanically or hydraulically dredging a boat slip and spur channel, providing beach nourishment to an adjacent beach, and providing for six-years of maintenance dredging.*  
*Stevensville, Eastern Bay*  
*Special conditions: Requirements for U.S. Coast Guard approval, dredge operator, inadvertent releases of dredged material into State Tidal Wetlands, and beach nourishment construction.*

***Remarks (cont'd):***

The construction efforts will entail modification to the internal boiler configuration and boiler room to include removal of equipment no longer required for operation; modification to existing catwalks; installation of new burners, economizers, and ancillary equipment; installation and programming of boiler instrumentation and controls; and installation of piping that will safely direct natural gas from the distribution point outside of the plant to the burner for each boiler.

New boiler equipment was procured under a separate MES contract with Delval Equipment (Delval; Secretary's Agenda, Item 14, 1/27/2021), the sole regional representative of the original equipment manufacturer (OEM) Cleaver-Brooks. Equipment procurement was performed separately due to long lead-times from the boiler OEM. This new equipment will be installed as part of the subject contract.

Based on differing code interpretations between HDR Engineering, Inc. and the original equipment manufacturer, MES engaged the authorities having jurisdiction (AHJ) for code interpretations in August 2021. In September 2021, the authorities having jurisdiction upheld HDR Engineering, Inc.'s code interpretation which required the original equipment manufacturer to update their equipment design. In March 2022, three months after MES received bids for the second public solicitation of the subject contract, HDR Engineering, Inc. determined these equipment changes required updates to some design aspects of the ECI Cogeneration Plant boiler fuel conversion project. HDR Engineering, Inc. upgraded the construction bid documents and released the Issued For Construction (IFC) documents with the necessary design changes. The contractor's review identified additional cost changes from the original construction bid documents. This change order is the result of MES negotiation of the equitable cost adjustment to implement electrical, instrumentation, and structural design changes.

The Contractor remains committed to the 17% goal and is planning to use two additional MBE vendors to achieve this goal. There have been no payments to MBE vendors to date. MBE participation is forecasted to begin during construction, which is scheduled to start in July 2023. Work tasks by MBE vendors includes mechanical systems installation, welding and inspection, and engineering consultation.

The MMC Building A, opened in 1983, is an integral component of the Maryland Food Center complex located in Jessup. The MMC Building A consists of one building with approximately 114,859 square feet of space and is currently sub-divided into 35 individual units. Food & food-related dealers own and operate specialized companies and lease offices, storage and dock facilities from the Authority.

The Authority also owns and manages the Maryland Wholesale Produce Market (the "Produce Market"). The Produce Market opened in 1976 and operates as an integral component of the Maryland Food Center complex located in Jessup, Maryland. The Produce Market consists of two buildings with approximately 330,000 square feet of space and is sub-divided into 101 individual units. The food and food-related dealers own and operate specialized companies and lease offices, storage and dock facilities from the Authority.

Reference is made to Secretary's Agenda, Item 8 (March 22, 2017), in which the Board of Public Works previously approved a three-year form lease and a five-year form lease for these units. The new proposed Form Leases have been updated to address such matters as developments in the law concerning compostable waste, including email as an acceptable method of Notice, and clarification of the composition of the Tenant Advisory Board.

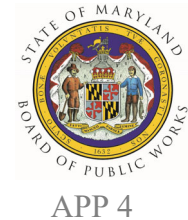

**Requesting Agency Remarks:** This contract provides work-order based planning services to support MDOT MTA's Office of Planning and Programming (OPP) and provides agencywide planning, staffing, and engineering efforts. The tasks provided for in this agreement range from small work orders with relatively quick turnaround periods to large, labor intensive engineering planning projects that have a great degree of complexity. As a result, additional funds are necessary due to the size and to the complexity of these projects. MDOT MTA was experiencing significant delays on various projects prior to the COVID-19 Pandemic (COVID), and these delays were later exacerbated by the global shutdowns. Despite recent inroads made in the fight against COVID, supply chain issues continue to hamper the projects associated with this contract. For instance, the LightRail Vehicle Overhaul, the Metro Railcar and Train Control, and various MARC Locomotive projects continue to experience significant delays due to the unavailability of critical materials and shipping slowdowns.

Additionally, MDOT MTA Zero Emissions Bus Buy project has also been adversely impacted by extraordinarily long lead times for equipment and materials, which has delayed the production of Battery Electric Buses. Consequently, additional support is required to maintain the continuity of services among the various projects associated with this agreement. Moreover, MDOT MTA has received an infusion of federal funding, which will, among other things, provide for major infrastructure enhancements – benefiting both MDOT MTA and the State of Maryland.

The totality of these circumstances has substantially increased Architectural and Engineering demands throughout MDOT MTA. Therefore, MDOT MTA seeks additional contract authority to support the projects associated with this contract.

**Impact of Delays:**

- **Inability to Add Work Orders** – WSP USA Inc. (WSP) has been unable to submit new work orders nor additional extra work orders for funding, which has adversely impacted their responsiveness to project needs. WSP is often tasked with quick-burn and legislatively mandated demands, such as work force reports and MARC Train related projects, due to their ability to deliver knowledgeable staff capacity in a timely fashion.
- **Ongoing Office of Planning & Programming Management Support and Special Projects Management** (E.g., fare free study, Fast Forward) – Due to the unavailability of additional funds, a broad strategic support team has been burdened by an unsustainably high volume of one-off tasks.
- **Zero-Emissions Transition and Workforce Training** – The WSP Zero Emissions Vehicle (ZEV) team has provided specialized and technically trained staff for MDOT MTA during the transition to zero emissions buses. The ZEV transition program is part of an agencywide mandate to convert 50% of MDOT MTA's bus fleet to zero emissions by 2030 and to later convert 100% of the fleet by 2045, which requires significant internal and external coordination. The slightest delay could significantly impact the ability to achieve this goal.

- **Discretionary Grant Support** – WSP is drawing down its remaining authority to shore up a discretionary grant support task to get through the next few months. However, anytime beyond that point is unlikely. New Infrastructure Investment and Jobs Act opportunities have created a year-long calendar of discretionary efforts, as opposed to previous years in which there was more of a “grants season.” Continuity of support for this task is essential to MDOT MTA’s competitiveness for federal funding.

Currently, MDOT MTA is working with the contractor to ensure this amendment will improve the allocation to the DBE firms. Submitted invoices indicate a DBE compliance rate of 17.92%. Therefore, it should be noted that, at the beginning of the contract, WSP experienced challenges matching DBE consultant skill sets with work orders requested by OPP. MDOT MTA is working with the vendor to identify appropriate sub-contracting opportunities. However, additional subcontracting opportunities greatly depend on the prompt availability of additional contract authority, which would ultimately provide WSP with a realistic path to DBE goal compliance.

Similarly, for out-of-State providers, a government organization in the provider's state establishes or approves standardized rates (the rate setting authority). For both in-State and out-of-State providers, DJS determines the not to exceed amount of the contract based on an estimated number of youth that may require these services annually. Contractors are paid only for the number of youth placed in the program and for the actual number of days they receive services. Daily or per diem rates are paid in accordance with the IRC (or the rate setting authority for out-of-State providers).

These services were procured through Non-Competitive Negotiated Procurement of Human, Social or Educational Services. (See State Finance and Procurement Article 13-106 and COMAR 21.14.01.03 G). The reasons for employing this method of procurement are:



The resource has become skilled at CCU operations, including current business processes, technology assessments to support future operations, and developed a phased approach to reduce risk to project implementation, in addition to leading the project team to execute multiple contract deliverables on schedule and within budget.

This project is to construct the 3,450 NASF/5,472 GSF Governor Leonard Calvert House Exhibit structure, which will replicate the home of Maryland's first Governor and complete the architectural backdrop of the museum's Town Center interpretive site. The exterior of the building will help restore the 17th century appearance of the Town Center. The interior will be a combination of architectural, archeological, and historical exhibitory. There will also be a control room as well as a changing room/costume storage area, working area, meeting space, and lunchroom for Town Center interpretive staff. A separate restroom for staff will be located in the building.

***Requesting Agency Remarks:*** Approval for the use and transfer of capital funds have been considered by the Department of Budget and Management (DBM) and they respectfully concur with this agreement. As identified in the approved Memorandum of Agreement (MOA) dated March 28, 2023 HSMCC will be the agency responsible for the management of the Archaeological efforts related to the project.

The Department of General Services is requesting approval for the entire project, which exceeds currently available funding. As future funding becomes available, the Department will return to the Board to authorize funding pursuant to such authorizations. Until then, the Department will only authorize work that does not exceed currently available funds.
