***Wetlands License -- #22-1164 – Lucy F. Richards  
Mitigation***

**Recommendation:** The Board of Public Works Wetlands Administrator recommends that the Board:

1. Grant a tidal wetlands license to dredge an area, and
2. Require mitigation in the form of *Phragmites* removal for impacts to shallow water habitat resulting from the dredging.

**MDE:** The Maryland Department of the Environment concurs with the recommendations.

- Application received November 2, 2022
- Public comment period ended August 1, 2023
- MDE Report and Recommendation February 8, 2024

**Authority:** Section 16-202, Environment Article, Annotated Code of Maryland: “*The Board shall decide if issuance of the [tidal wetlands] license is in the best interest of the State, taking into account the varying ecological, economic, developmental, recreational, and aesthetic values [the] application presents.*” See also COMAR 23.02.04.

**Mitigation:** Dredging an area will result in permanent impacts to 395 square feet of shallow water habitat. MDE recommends that the licensee mitigate for the 395 square feet of impact to shallow water habitat at a 2:1 ratio (COMAR 23.02.04.11.B) by removing 1,359 square feet of *Phragmites*. The 1,359 square feet of *Phragmites* removal exceeds the required mitigation amount of 790 square feet.

395 square feet of impact x 2 (2:1 ratio) = 790 square feet of required mitigation

***Recommendation:*** That the Board of Public Works approve the Department of Natural Resources granting \$433,363 in general obligation bond proceeds to construct one restoration project.

***Project ID:*** Tilghman on the Chesapeake / CRP 03-21

***Authority:*** Section 8-301, State Finance and Procurement Article,  
Annotated Code of Maryland

***Grantee:*** Talbot County

***Location:*** Tilghman Island

***Amount:*** \$433,363

***Remarks:*** This project will construct a permitted 665 linear foot living shoreline with vented marsh sill, concrete oyster breaks, marsh migration corridor, and sand dune features alongside a 0.16-acre non-tidal wetland and a 2.4-acre meadow at the Tilghman on the Chesapeake community on Tilghman Island. This project will serve as a demonstration site for the Talbot County Green Infrastructure Plan and help protect existing residential infrastructure from high tide flooding, storm, and stormwater impacts. DNR is seeking approval to award construction funds for this green infrastructure project. After construction, DNR may return to the Board for approval to award adaptive management funds depending on local fund requests.

The Resiliency through Restoration Initiative was developed to address escalating risks to Maryland's coastal and inland communities and public resources from extreme weather and climate-related events. This Program implements on-the-ground natural and nature-based projects in priority areas where nature can help communities become more resilient to impacts from water. Targeting models, such as the Coastal Resiliency Assessment, identify areas where restoration can provide the greatest protection benefits for infrastructure, communities, businesses, and habitats. Datasets, such as impervious cover, highlight urban and inland areas where green infrastructure is needed to address more intense rain events. Projects will protect both public and private investments, while demonstrating a suite of nature-based projects that will enhance the ability of communities to respond to or recover from extreme hazards like storms and more frequent and intense rain events, or chronic hazards like nuisance flooding and sea level rise.

**Remarks:** The project was open for solicitation to five vendors, but only three contractors participated in the competitive process. All the participants were deemed capable of winning the award and were moved forward through all the phases of the selection process.

LAZ Parking Mid-Atlantic, LLC submitted a Technical Proposal demonstrating a comprehensive understanding of the challenges faced by the University. Their License Plate Reader systems knowledge was recognized as critical to the University's future operational success. The solutions presented for Parking Garage Management, Parking Enforcement, and Event Parking, such as e-commerce functionality and systems integration, allow for a more automated approach to parking management, reducing the strain on internal campus departments. These programs, combined with the references provided by LAZ Parking, conveyed a comprehensive solution to Morgan State University's parking management needs.

The award was based on the source selection process, which identified LAZ Parking as the highly acceptable vendor based on a license plate recognition system for parking enforcement and management that will provide an innovative approach to elevate many of the stresses on our existing parking system.

Although the Financial Proposal submitted by LAZ Parking demonstrated a 17.13% increase over the nearest competitor's pricing, the increased costs are justified, as the innovations and automation will reduce the need to hire additional personnel within the University. LAZ Parking's solution will provide long-term cost savings and improve the efficiency of our parking management system.

***Requesting Institution Remarks (cont'd):*** Chartwells provided FSU with the most advantageous proposal overall considering both the technical and financial. The recommended firm, Compass Group USA, by and through its Chartwells Division, is the incumbent contractor and has performed well during the previous contract period.

The proposed contract will have a five-year term with one five-year renewal option that will require the approval of the Board of Public Works if FSU requests to exercise that option. The contract provides for a minimum Minority Business Enterprise goal of 3.5% that was established in consultation with the Governor's Office of Small, Minority & Women Business Affairs.

This dining services management/revenue generating contract is estimated to cost \$34 million over the five-year base term. The total estimated value of the contract if the one five-year option is exercised would be estimated at \$70 million. The actual costs will be a function of the volume of meal plans purchased by students. The source of funding for the contract will be dining program revenues paid by student, catering and retail sales. The vendor will provide \$5,896,035 for capital investments in dining area renovations and food service equipment upgrades throughout the term of the contract. This capital investment is amortized over the potential ten-year term if the renewal option is exercised.

***Fund Source:*** This is a revenue-generating contract from which approximately \$34 million will be paid to the vendor over the initial five-year term of the contract from the student board fees. The University will receive an 18% commission on retail, franchise, catering, and concession gross sales. Increases in board fees and cash-sale prices will be indexed to the food and beverage CPI-U category (food away from home).

***Requesting Institution Remarks:*** On June 22, 2016, the IT Professional Consulting Services master contract was approved by the Board of Public Works with a not to exceed amount of \$90 million (USM Item 1-S). The USM and MEEC requests the approval to increase the not-to-exceed amount from \$90 million to \$140 million. Of this amount, \$5.4 million is considered retroactive as the not to exceed amount was breached at the end of year seven of the contract in December of 2023.

On December 5, 2023 USM learned that the not-to-exceed amount of this master contract had been breached. A moratorium was issued on any new task orders off of this master contract until a contract modification to increase this amount could be considered by the Board of Regents and the Board of Public Works. The Board of Regents approved this increase on February 16, 2024.

Usage of the contracts varies by institution and the increase in spend was due in part to several USM institutions replacing their ERP systems. The requested increase in the not-to-exceed amount is critical to USM institutions to continue existing projects. It is anticipated that for the remainder of the term of the contract an additional \$44.6 million is necessary. Although the original contract approved by the Board of Public Works did not establish an overall MBE goal, three of the twenty-six firms are certified minority business enterprises. The overall MBE participation inclusive of MEEC members, is 3.5%

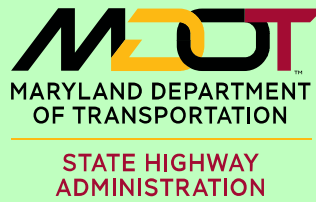

The NTE award amount differs from the financial proposals because the evaluated pricing is based on a calculated hourly rate to evaluate the financial proposal of each offeror.

The consultants will be available to all state agencies and the University System of Maryland to plan for compliance with Building Energy Performance Standards (BEPS) and to meet the state's greenhouse gas emissions goals. BEPS covers all state-owned buildings greater than 35,000 square feet, which totals approximately 60-70 million sq. ft. of state-owned facilities. Work orders could specify high-level plans to help develop budgets, or could be facility/building specific engineering designs. There is a great deal of interest from USM and MDOT to use the services that will be available through these consultants.

It was determined that it is in the best interests of the State to award this single-bid contract because ample opportunities were provided to obtain competition, and the bidder is uniquely qualified to provide the required services. The deadline was extended ten separate times for a total of 70 days on eMMA, and the vendors who were directly solicited originally were notified of the various extensions and encouraged to bid. After the final extension, the Procurement Officer requested feedback from vendors who decided not to bid on the No-Bid Form in the IFB, but none responded. Due to the unique challenges of providing skilled maintenance in multiple trades at correctional facilities, this contract requires a vendor who has demonstrated that it can successfully perform those tasks in a prison environment. CGL is not the only company that qualifies, but they are a leader in that sector, having provided services in over 900 municipalities in all 50 states.

The billing rates for the new contract were compared to what DPSCS is currently paying for those services at BCCC and Jessup. For eight positions, which are provided on the current contract, prices ranged from a 2.75% to 23.75% increase, with a median increase of 11.28%, and a decrease of 18.13% for HVAC technicians. Per the terms of the IFB, those prices must remain fixed for the three-year base term of the contract, considering projected inflation as well as increased labor costs, with the \$15.00 per hour minimum wage law that went into effect on January 1, 2024. The price has been determined to be fair and reasonable.



**Requesting Agency Remarks:** MTA seeks approval of a retroactive modification to pay the contractor as MTA exhausted their contract authority on June 30, 2023, and a proactive modification to increase MTA's contract authority and contract term by 22 months and 1 day, as outlined below.

**Part A (Retroactive):** Retroactive approval is requested to ratify this modification increasing to increase contract authority by \$10,389,688.26 for payment. This agenda reflects that the modification exceeded MTA's delegated authority without BPW approval, and that MTA, and DGS seek ratification of this retroactive modification on the agenda item.

**DGS OSP Remarks: RETROACTIVE** approval requested pursuant to §11-204(c) State Finance & Procurement Article. DGS OSP has determined that this contract should be treated as voidable rather than void because: (1) all parties have acted in good faith; (2) ratification for the procurement contract would not undermine the purposes of the Procurement Law; and (3) the violation, or series of violations, was insignificant or otherwise did not prevent substantial compliance with the Procurement Law.

**Part B (Proactive):** MTA requests approval for a time extension of 22-months and 1 day, as well as an increase in contract authority, to allow MTA to complete the procurement currently underway for a successor contract.

This contract provides for management and technological services to support the Call-A-Ride same-day premium supplemental services. Additionally, the vendor is responsible for contracting with taxi and sedan companies operating non-dedicated vehicles and monitoring their performance.

#### ***Agency Remarks: (cont'd)***

The Call-A-Ride program is operated by MTA's Office of Mobility. The provision of these services to disabled and elderly persons is federally mandated and operates within MTA's core service area which includes Baltimore City, Baltimore County, and Anne Arundel County. Currently, this service is provided to more than 14,000 customers who are certified under the American with Disabilities Act (ADA-certified) as not possessing the functional ability to use local fixed-route services and who live within a certain distance from a fixed transit route. The Call-A-Ride program offers flexibility to users.

Due to the pandemic, there was low ridership resulting in excess funding which is why MTA exercised renewal option two without additional funding (Mod.3 MTA Delegated Authority; 1/21/2022).

In August 2022, the MTA advertised an RFP for Contract No. MOL-22-038-SR with the expectation of making an award in Spring 2023. However, two protests were received in February 2023, one protest was denied and the other has been sustained in part by MTA, resulting in a second round of evaluations.

When invoicing was processed in August 2023, it was noted that the contract authority was exhausted starting in July 2023. The contractor continued to provide these essential services as it impacts the health and welfare of these riders.

To ensure continuity of these essential mobility services, the MTA is seeking a time extension and increase in contract authority to allow MTA to complete the procurement currently underway and resolve the protest.

A 4% MBE and 0.5% VSBE participation goal on the contract fees was established for this contract based upon the limited subcontracting opportunities and elements of work. The pass-through payments to the local taxi and sedan companies for transporting participants cannot be included in the MBE and VSBE participation goals. Currently, the vendor is exceeding the MBE goal with a participation rate of 4.15% and just below the VSBE goal with a participation rate of 0.46%.
