***Wetlands License -- #23-1108 – Maryland Department of Natural Resources
Mitigation***

Recommendation: The Board of Public Works Wetlands Administrator recommends that the Board:

1. Grant a tidal wetlands license for work at Elk Neck State Park in Cecil County to remove stone breakwaters, place stone to create a breakwater, construct a groin and stone revetment, hydraulically dredge two areas, restore historic beach with dredge material, and
2. Require mitigation for impacts to submerged aquatic vegetation (SAV) and open water habitat by converting uplands to open water and restoring existing, disturbed SAV beds.

MDE: The Maryland Department of the Environment concurs with the recommendations.

- Application received December 4, 2023
- Public comment period ended December 15, 2024
- MDE Report and Recommendation February 26, 2025
- MDE Report and Recommendation (revised) March 10, 2025

Authority: Section 16-202, Environment Article, Annotated Code of Maryland: “*The Board shall decide if issuance of the [tidal wetlands] license is in the best interest of the State, taking into account the varying ecological, economic, developmental, recreational, and aesthetic values [the] application presents.*” See also COMAR 23.02.04.

Mitigation: The below mitigation amounts were negotiated and agreed upon by NOAA Fisheries and MDE.

1) Hydraulic dredging will result in permanent impacts to 8,027 square feet of open water. MDE recommends that the licensee mitigate for the 8,027 square feet of impact to open water by removing 12,640 square feet of breakwater and converting 31,985 square feet of uplands to open water. This is a 5.5:1 mitigation ratio, exceeding the mitigation ratio requirement.

8,027 square feet of impact x 5.5 (5.5:1 ratio) = 44,148.5 square feet of mitigation
44,625 square feet of new open water (mitigation) provided

2) SAV impacts for the project total 53,589 square feet. MDE recommends that the licensee mitigate for the 53,589 square feet of impact to SAV at a 2:1 ratio (COMAR 23.02.04.11) by restoring 132,762 square feet of nearby, disturbed SAV, exceeding the 2:1 mitigation ratio requirement.

53,589 square feet of impact x 2:1 = 107,178 square feet of required SAV restoration
132,762 square feet of SAV restoration (mitigation) provided

CECIL COUNTY

23-1108 *MARYLAND DEPARTMENT OF NATURAL RESOURCES* – To redesign a breakwater system to allow seasonal accretion and erosion of sediment along the shoreline by removing stone breakwaters, placing stone to create a breakwater, constructing a groin and stone revetment, hydraulically dredging areas, removing 53,589 square feet (1.23 acre) of submerged aquatic vegetation (SAV) and restoring historic beach. Mitigation will be provided for impacts by creating open water from uplands and restoring disturbed SAV.

North East, Chesapeake Bay

Special conditions: Time of year restriction. Requirements for design and construction of revetment, maintenance dredging, dredge material transport and disposal, post dredge bathymetric survey, constructing DMP site if hydraulic dredging is performed, installing, marking, maintaining dredged material pipelines, if Licensee does not obtain U.S. Coast Guard approval, if the U.S. Coast Guard's approval alters the proposed pipeline route, dredge operator, protocol in event of an inadvertent release of dredge material, constructing beach nourishment, deploying and maintaining turbidity curtain, SAV restoration, and SAV monitoring reports. Restrictions on use of asphalt rubble in revetment.

Project Description: The purpose of the project is to rehabilitate and replace the equipment and systems of the existing Cromwell Pump Station. Work will include major upgrades to the pump system, disinfection feed, electrical components, mechanical equipment, facility security, site grading, building structure, and all appurtenances. The Cromwell Pump Station is aging and must be rehabilitated to maintain safe and reliable service to the water distribution system. This project is needed to maintain a reliable drinking water supply to the homes and businesses of Baltimore. This project will be constructed in accordance with coastal and non-coastal resiliency guidelines developed as part of the Coast Smart Program to reduce climate change risks to such projects.

Financing Description:

Project: LCRR Compliance Program - Inventory - City of Baltimore

Project Description: This project entails contracting professional services to develop a Lead Service Line (LSL) Inventory for the City of Baltimore under the Lead and Copper Rule Revisions (LCRR), issued in December 2021. Scope of work will involve planning phase services, to conduct a lead service line inventory in compliance with EPA's LCRR. Scope involves historical records surveying, point investigations, inventory programming, predictive modeling of service line materials and other related work. Baltimore City currently services approximately 1.6 million users in its drinking water system, portions of which are up to 100 years old. Due to the age and size of this system, the potential of lead service lines would have significant impacts on users. Completing this inventory of service lines is the first step before LSL replacements and will have enormous public health and safety benefits for a large utility area. This project will be constructed in accordance with coastal and non-coastal resiliency guidelines developed as part of the Coast Smart Program to reduce climate change risks to such projects.

Project Description: This project entails the rehabilitation and point repair of various sewer lines in the Herring Run Sewershed based on sewershed study reports. The work will involve cure-in-place pipe lining (CIPP), open cut point repairs, and sanitary house connection repairs, along with various sanitary sewer manhole rehabilitations. Completion of this project will reduce inflow and infiltration (I&I) for basins identified as high I&I sources under the Modified Consent Decree between Baltimore City and MDE/EPA. This project is consistent with Maryland's climate change adaptation and resiliency objectives through the reduction of runoff that is exacerbated by increased precipitation or flooding events.

Charter Linkz's proposal was deemed nonresponsive and subsequently rejected.

The apparent recommended awardee, RTW Management, Inc., initially submitted a proposal priced at \$3,178,876, which was deemed excessive. In accordance with the solicitation, discussions were initiated regarding the offeror's proposed labor rates. As a result, the contractor agreed to reduce their labor rates, leading to a price reduction of \$324,000.

On August 22, 2024, Charter Linkz submitted the last of three timely protests. On November 7, 2024, the Director of Procurement issued a Final Decision denying all three protests. On November 12, 2024, Charter Linkz filed a Notice of Appeal of the Final Decision dated November 8., 2024. That same day, the appeal was docketed and assigned Docket No. MSBCA 3290. On December 5, 2024, the Agency Report was filed with the Board of Appeals.

On January 14, 2025, the appellant's attorney and the state discussed an agreement to dismiss the appeal once the re-compete for Shuttle Bus Service was issued. On January 31, 2025, a Joint Request to Place the Appeal in Suspension pending settlement negotiations was filed. On February 7, 2025, the re-compete RFP was released and sent to the appellant and other competing offerors. On February 27, 2025, the appellant filed a notice of withdrawal of the appeal.

**6A. CONSERVATION RESERVE ENHANCEMENT PROGRAM
*Hays, David & Samantha, Washington County***

Recommendation: Approval to grant \$653,387.79 to Washington County from Program Open Space Stateside Funds to acquire a 127.05-acre Conservation Reserve Enhancement Program easement.

Background/Prior Approvals: Reference is made to Program Open Space Agenda Item 14A (January 3, 2024) in which the Board of Public Works approved the Conservation Reserve Enhancement Program (CREP) easement acquisition program and authorized the use of Program Open Space funds to be used for acquiring permanent conservation easements on stream side forests, natural areas and wetlands.

Project Description: Acquisition of this CREP easement permanently protects water quality by retaining 6,400 linear feet of forested buffers along Conococheague Creek, Rush Run, and unnamed tributaries. As part of the transaction, the landowner will be donating 3.16 acres of the property into the easement for 130.21 acres of total protection. The easement, CREP No. 35444 and POS No. 35445, will be held by Washington County and the Maryland Department of Natural Resources.

Requesting Agency Remarks: The solicitation was previously advertised as a Small Business Reserve (SBR) Procurement on September 7, 2023, two bids were received on January 11, 2024. A review of the bid package submitted by Bidder one revealed that its bid did not conform in all material respects to the requirements contained in the Invitation for Bids.

1-C. **MARYLAND AVIATION ADMINISTRATION** *(cont'd)*

Requesting Agency Remarks (cont'd):

Specifically, the bidder failed to meet the MBE Participation Schedule requirements set forth in the solicitation. Bidder two's bid exceeded the budgeted amount for the project. Therefore, the Procurement Officer determined that rejecting all bids and canceling the procurement was fiscally advantageous or otherwise in the State's best interest.

The amended solicitation was re-advertised as MAA-CO-25-003, Concourse D/E Patio Leak Repairs at BWI Thurgood Marshall Airport on July 30, 2024, as an SBR Procurement via eMaryland Marketplace Advantage notifying 150 potential contractors, the Maryland Aviation Administration's website, and by way of direct solicitation to six prospective bidders. Two bids were received on October 17, 2024.

MAA requested and reviewed the Schedule of Values for each bidder. It was determined that the variance in the bids was attributed to Eastern Waterproofing & Restoration of Virginia, LLC specializing in this type of work, so they were able to provide more competitive pricing. MAA reached out to the non-bidding vendors to ascertain why they did not bid. No responses were received.

The MAA Procurement Review Group (PRG) reviewed the contract scope of work for MAA-CO-25-003 to determine the potential for establishing MBE and Veteran-Owned Small Business Enterprise (VSBE) goals, as well as a Small Business Enterprise designation. A 23% MBE participation goal and a 1% VSBE goal were established for this contract. The project is designated as SBR.

On September 24, 2024, the MAA PRG revisited the contract scope of work for MAA-CO-25-003 based on a potential bidder requesting a reduction to the MBE goal due to the nature of the work and narrow scope. The MAA PRG reviewed the potential sub-contractable items and recognized the difficulty identifying subcontractors capable of meeting the 23% MBE participation goal and the 1% VSBE participation goal. In addition, the prior solicitation was cancelled in part due to the failure of a Bidder meeting the established MBE goal. As a result, the MAA PRG decided to isolate the MBE participation goal specifically on the installation of interior drywall and painting, which reduced the MBE participation goal to 10% and the VSBE goal to 0%. This approach was deemed feasible for achieving the revised target. Although the goal was reduced via Addendum to the solicitation, Eastern Waterproofing & Restoration of Virginia, LLC, has committed to exceeding the MBE goal by 13% to achieve 23% MBE participation.

However, the contract and any modifications must be approved by the Board of Public Works because the contract constitutes a use of State Property under State Finance and Procurement Article, §10-305.

Requesting Agency Remarks: On August 28, 2023, the solicitation was advertised in The Daily Record and on eMaryland Marketplace Advantage (eMMA). The advertisement sought two contracts, each valued at \$3 million, for construction management and inspection services for the MDTA. A total of 346 firms were notified through eMMA, and 106 received direct solicitations. The MDTA received 12 technical proposals. One firm's proposal was rejected in accordance with COMAR 21.11.03.09.C (6) because it omitted the Minority Business Enterprise (MBE) and Veteran Small Business Enterprise (VSBE) forms. For the 11 remaining firms, MDTA utilized the qualifications-based selection process, ultimately identifying two consultants as eligible for contract awards. No protests were filed.

The services to be provided include: constructability reviews, pre-construction conferences, monitoring and documenting contractor performance, detailed inspections of all construction work including erosion and sediment control, contract compliance, environmental project/program monitoring, review of contractor safety program and inspections, maintenance of traffic, scheduling and conducting progress meetings, detailed materials inspections and testing (this may include providing full service laboratory to conduct said testing), contract utility coordination and locating of existing facility utilities, , project critical path method and cash flow schedules, review and processing progress and final payments,

utilizing Maryland Construction Management System, use of the eMaryland Construction Management System, or other construction management software approved by the MDTA, construction phase review services such as reviewing shop drawings and responding to Requests for Information, on-site program management support, and assist the MDTA compliance program officers with monitoring and enforcement of MBE goals.

The MDTA Procurement Review Group evaluated the contract's scope of work to determine the feasibility of establishing an MBE participation goal and a VSBE participation goal, along with a Small Business Reserve designation. It was determined that a 25% MBE participation goal and a 1% VSBE participation goal would be established for each contract. O'Connell and Lawrence have agreed to exceed the VSBE goal by 2%, resulting in a total VSBE goal of 3%. iCivil has committed to a 27% MBE goal and a 2% VSBE goal, surpassing the established MBE and VSBE goals by 2% and 1%, respectively.
