Treasurer. For the record, I'm Atif Chaudhry, Secretary of the Maryland Department of General Services. Today, the Department is presenting 64 items in our agenda. We are withdrawing two items today, Items 28-C and 31-S. I will actually save my comments because I'm going to try to see if we can set a record today on the Board – for the Board. I was told by my colleague here, Dave Bohannon, that the record is 17 minutes and 40 seconds, but ensures the Board (indiscernible) – So, to just let you know, that continuing to keep an eye on minority business contracting we have 10 contract awards and modifications for certified minority businesses totaling \$8.6 million on our agenda today, and we have representatives here answering questions you may have.

On Item Number 38, these are -- the Department is moving forward with approving task orders from the old contracting vehicle, despite the

fact that there's a new contracting vehicle and that the new contracting vehicle was said to be urgent. And so I'm wondering how (indiscernible) keep doing these IT procurements under the old vehicle and why is this happening?

MR. CHAUDHRY: Sure. Great question, Madam Comptroller. And I think you're probably referring to a specific task order, I think. So it's a couple things there. I would say that when it comes to the contracts that are approved, the prior AGILE contract we approve at the Board of Public Works, those particular contracts that are using federal funds do require 60 day-window for approval from the federal government. So we're working through that right now. So agencies that leverage that particular contract will have to wait for that 60 day-window to close to get the federal approval and then issue work orders off of that particular contract. And there are still contracts here that we will be utilizing here for smaller ones that we will be eventually transitioning to the other ones. So there are other ones that -- I know Item 38-IT is a big agenda, so it's multiple task orders off of multiple contracts. Master contracts, some of them are related to other hardware-related contracts, not just necessarily AGILE.

COMPTROLLER LIERMAN: Okay. Thank you.

gardens, social gatherings spots, and other multipurpose areas that all of La Plata's residents can enjoy. For more about this exciting project, I'd like to turn it now over to La Plata Mayor Jeannine James, who is joining us this morning.

Good morning, Mayor James.

MAYOR JAMES: Good morning. It is wonderful to see -- for the record, Jeannine James, Mayor of the Town of La Plata. If you haven't visited us, come on down. Pull off at 301, we've got a lot to show you. Thank you very much for the opportunity to really advocate for this amazing opportunity for our youth.

A little background story how this came about. About ten years ago, our police officers were patrolling an area that seemed to have a lot of activity. And there was a young boy, 12 years old, chasing another young boy with a gun. And our police officer was able to diffuse the situation. It happened to be a very good replica, but we -- the young man went and followed all of the orders of the police officer, and crisis was averted. It could have been a disaster.

On that point, our chief said, "We need a place for our children to go." When kids are busy, there's less activity and that had been proven. So we had started what's called the Dorchester Community Center on Kent Avenue -- the name changed a little bit -- and it has been a success. The programming. We had -- our Coach B has taken these young youth with no future, put in a basketball court and these young men have now -- some of them are in college on full scholarships. And that's the success story that we love.

Well, then there was a little bit of a hiccup there. The place that we had, which we have designed for what we were using, had mold. And we never want kids in there with mold. We remediated the mold, but guess what; it came back again. So the reason for this funding is we do have a design; we do have a plan. It's to give our youth a chance. It's to give them a place -- a safe

place to learn, to mentor, to have an escape from reality for just a minute there. So I am asking you to have a favorable report. And any questions that you may have for me, I am willing to answer.
