Three (3) locations were removed from further MTA solar development consideration since the sites were prioritized for transit- oriented development (TOD). Removing the three (3) sites will alter the scope of work (SOW) of the TORFP significantly and no longer make the project financially advantageous for MDOT to support MTA's Solar Photovoltaic (PV) systems project due to significant costs to the State for removal of sites as a result of the early termination fees authorized under the TORFP. This decision to reject all proposals is made in accordance with COMAR 21.06.02.02(C)(1), "After opening of … proposals but before award, all … proposals may be rejected in whole or in part when the procurement agency, with the approval of the appropriate Department head or designee, determines that this action is fiscally advantageous or otherwise in the State's best interest."
