<p>MAA advertised an expression of interest for refurbishment of Plane-Mate and only received one response. After further research, MAA determined the Plane-Mate refurbishment was a sole source and began negotiations with the Contractor. The cost proposal submitted by the contractor to refurbish the two antiquated Plane-Mate exceeded the funding MDOT MAA has available. Therefore, MDOT MAA has determined in accordance with COMAR 21.06.02.02.C, that rejecting the offer and canceling the procurement is fiscally advantageous or otherwise in the State's best interest. MDOT MAA is in the process of reviewing other alternatives to the Plane-Mate which may prove to be cost beneficial.</p>

The MEI BNA57 note acceptor is an integral part of the Cubic Transportation System Model 9383-1000 Ticket Vending Machine which is used by MDOT MTA's MetroSubway Link and Light RailLink systems to vend tickets to the public. The RFP resulted in a single proposal being received. In accordance with COMAR 21.06.02.02.c, the Procurement Officer rejected all proposals and canceled the RFP, with the approval of the Agency Head.</p>
