#### **EXECUTIVE SUMMARY**

Maryland's Veteran-Owned Small Business Program enhances opportunities for veteranowned small businesses and service-disabled, veteran-owned small business to participate in State procurements.<sup>1</sup> State agencies must structure their procurements to annually expend – directly or indirectly – at least 1% of the total dollar value of procurement contracts with veteranowned small business enterprises.<sup>2</sup> To qualify for participation, a veteran-owned small business must be verified by United States Department of Veteran Affairs which maintains a directory of verified businesses.

The Board of Public Works compiles annual reports from each agency and reports statewide progress to the Legislative Policy Committee. Fiscal year 2016 is the Program's fourth reporting year. Key findings are:

- Most agencies found it difficult to meet the State's goal of 1%. Veteran-owned small business participation for fiscal year 2016 is 0.24% approximately one-fourth of the Statewide goal. However, participation for fiscal year 2016 reflects an increase of .02% over the 0.22% participation rate in fiscal year 2015, and is a significant increase over the 0.097% participation rate in fiscal year 2014 and the 0.016% participation rate in fiscal year 2013.
- Four agencies exceeded the State's 1% participation goal in FY 2016:
  - Workers' Compensation Commission 4.66%
  - Motor Vehicle Administration 4.48%
  - Department of Labor, 3.93% Licensing & Regulation
  - Maryland Aviation Administration 1.45%
- One agency with more than a billion dollars in annual contract awards the State Highway Administration reported only 0.18% veteran-owned small business participation for fiscal year 2016.
- Previous reports have recommended that the Program's effectiveness may be improved if a single agency were designated to oversee the Program; marketing efforts increased, and agency training/awareness heightened. While the Department of Veterans Affairs has agreed to provide assistance with vendor outreach and has made efforts to improve agency training/awareness of the Program, this recommendation stands.

#### I. Veteran Owned Small Business Program

The Veteran-Owned Small Business Program, enacted in 2010, requires State agencies to try to expend a minimum of 1% of the total dollar value of agency procurement contracts directly or indirectly on veteran-owned small businesses. Veteran-owned status is verified by the U.S. Department of Veterans Affairs.<sup>3</sup>

#### Who Qualifies as a Veteran Owned Small Business/Disabled Veteran-Owned Business?

The Program criteria to qualify as a veteran-owned small business or a service disabled veteran-owned small business are:

- Business is owned by a veteran or service-disabled veteran as determined by the U.S. Department of Veterans Affairs or the U.S. Department of Defense.
- Veteran has unconditional direct ownership of at least 51% of the business.
- Business is classified as "small" under the North American Industry Classification System (NAICS) code assigned to the procurement.
- Veteran holds the highest officer position and is the highest paid employee unless there is a reasonable explanation submitted by the veteran as to how taking a lower salary than other employees helps the business.
- Veteran manages the company on both a strategic policy and a day-to-day basis.
- Veteran has managerial experience of extent and complexity needed to run company.<sup>4</sup>

More than 9,180 verified veteran-owned small businesses are listed in the U.S. Department of Veterans Affairs directory (the VetBiz Directory).<sup>5</sup> More than 700 verified businesses are located in Maryland.

#### Scope of Report

The Board of Public Works must annually collect compliance reports from each State procurement agency and report to the Legislative Policy Committee on the amount of contracts awarded to veteran-owned small business and on the effectiveness of the program.<sup>6</sup> Agencies that are exempt from the State Procurement Law, such as the University System, are exempt from the Program and do not report their data to the Board.

#### III. Program Effectiveness

Although the overall participation rate for fiscal year 2016 (0.24%) is up significantly from fiscal years 2013 (0.016%) and 2014 (0.097%), 50% of agencies reported 0% veteran business participation; which is consistent with fiscal year 2015. While the higher overall participation rate emphasizes that agencies have continued to make strides in increasing their participation rate year over year, many agencies still have not fully integrated veteran business goal-setting and outreach into their procurement operations. Agencies should be assessing opportunities for veteran business participation in each solicitation, just as they do with the MBE and Small Business Reserve Programs.

Obstacles that continue to affect agencies' ability to obtain veteran business participation include:

- Businesses providing certain categories of work such as social services are underrepresented in the VetBiz Directory.<sup>7</sup>
- Insufficient training on best practices to implement the Program.

#### IV. Recommendations to Improve Effectiveness

#### Designate a single agency to implement the Program

The previous three years' reports recommended that a single Program oversight agency be designated to be responsible for auditing compliance, developing reporting mechanisms, training in use of the VetBiz Directory, and coordinating outreach activities. While the Department of Veterans Affairs has agreed to provide assistance with vendor outreach and has made efforts to improve agency training/awareness of the Program, the recommendation is offered again this year. A lead agency can track agency procurement activity and inform agency heads during the course of a year when their participation rates are unacceptable, so those agencies can take corrective action when it matters.

#### Explore strategies to increase veteran-owned small business participation

- Some veteran-owned businesses are eligible to also participate in the State's other longstanding socioeconomic procurement programs the Minority Business Enterprise Program and the Small Business Reserve. Agencies should encourage veteran-owned businesses to seek State certification as MBEs and small businesses to maximize business opportunities for those firms. Under the MBE Program, agencies seek to spend 29% of contracting dollars with certified MBEs.<sup>8</sup> In FY 2015, Maryland awarded more than \$2.3 billion in prime and subcontract awards to certified MBEs. Under the Small Business Reserve Program, designated agencies must structure their procurements to ensure at least 10% of procurement dollars are expended directly with businesses certified by the State. In FY 2015, the State made payments totaling more than \$418.7 million to Maryland-certified small businesses.<sup>9</sup>
- Encourage State buyers to use veteran-owned small businesses for small procurement awards that typically do not have subcontract goals.

#### Increase Marketing Efforts

- Each agency website should include information on the Program.
- Veteran businesses should be encouraged to register on *eMaryland Marketplace* so they are notified of all State and local procurement opportunities.
- Agencies should coordinate with the Maryland Department of Veterans Affairs to participate in outreach events.
- The Procurement Advisor will continue to emphasize the importance of the Program at meetings of the Senior Procurement Advisors Group and the Procurement Advisory Council.

#### V. Conclusion

To improve the veteran-owned small business participation rate, State agencies must fully integrate veteran business goal-setting into their procurement operations as they do with the Minority Business Enterprise and Small Business Reserve Programs. Designating a lead agency that can enforce accountability and best practices will go far in bridging the gap between agency performance and the State's goal of increasing State contracting opportunities for veteran-owned small businesses.
